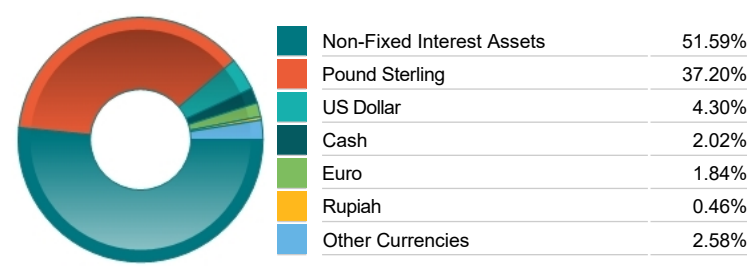
Regional Allocation
