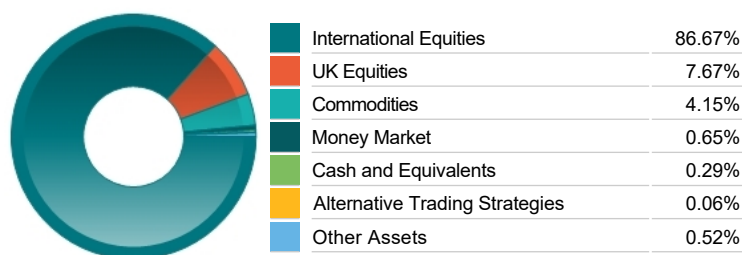

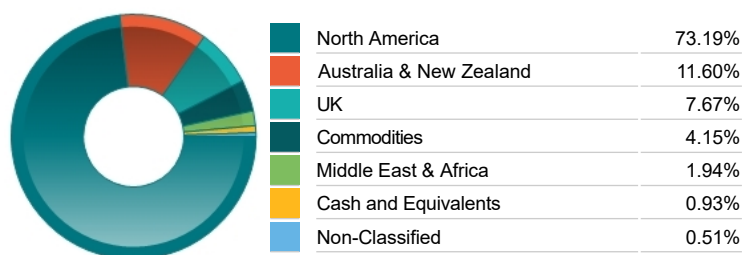

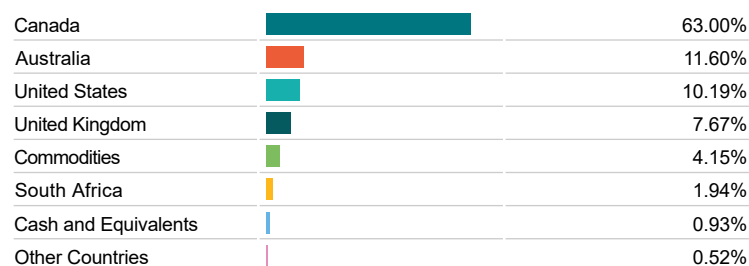
Regional Allocation



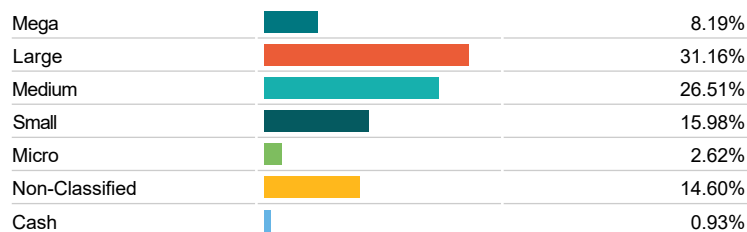
Equity Sector Breakdown
