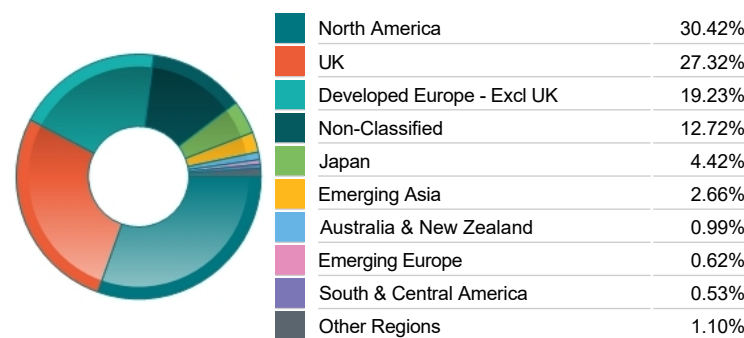

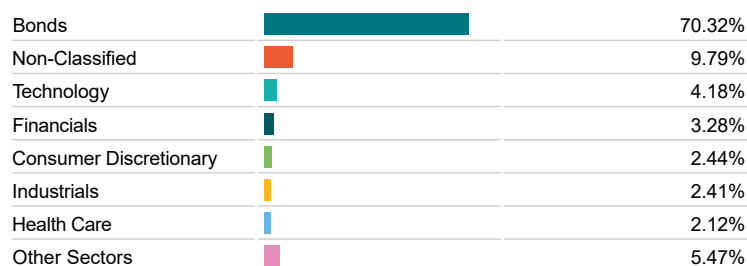

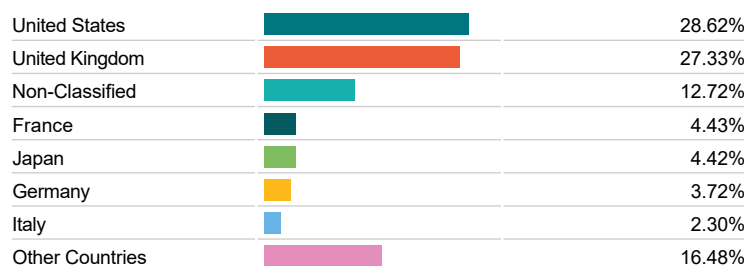
## Regional Allocation



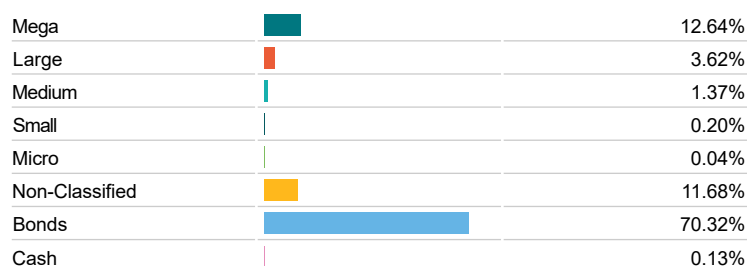
## Sector Breakdown



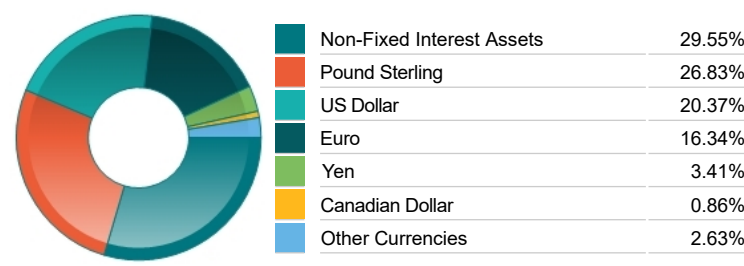

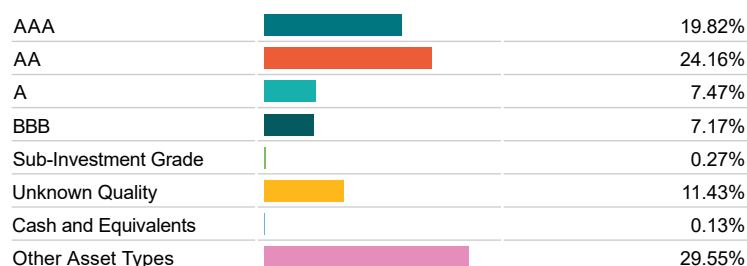
## Breakdown By Market Cap (%)



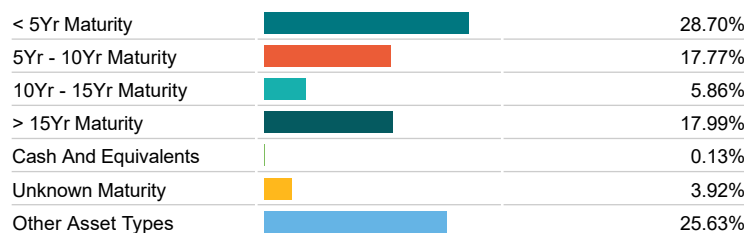
