Objectives and investment policy

The fund aims to make a return for you through a mixture of generating income and growing the amount you originally invested. It mainly invests in bonds issued by financial institutions that pay a fixed or variable interest.

The fund is actively managed and targets better returns than its benchmark, which is made up of Composite index comprised 50% of JP Morgan Emerging Market Bond Index Global Diversified and 50% JP Morgan Corporate Emerging Market Bond Index (CEMBI) Diversified, while taking into account Environmental, Social and Governance ("ESG") considerations. There are no restrictions on the extent to which the fund's portfolio and performance may deviate from the ones of the benchmark. As part of the investment process, the Investment Manager has full discretion over the composition of the fund's portfolio and may take exposure to companies, countries or sectors not included in the benchmark. At least two-thirds of the fund's investment will be in fixed income bonds of any rating, or unrated, issued by entities based in emerging market countries. The fund will be actively exposed to hard currency (generally, globally-traded currencies from economically and politically stable countries) investments but not local currency (currencies of emerging market countries) investments. The fund meets the conditions set out in Article 8 of the Sustainable Finance Disclosure Regulation as it promotes environmental/social characteristics through binding requirements as a key feature. ESG approaches applied include the exclusion of issuers which do not meet certain ESG considerations based on their economic activity or conduct and the outcome of the ESG evaluation. The Fund's exposure to issuers deemed by the Investment Manager to have 'very high' ESG risks is limited to 10% of its net assets on a case by case basis depending on the issuer's improving ESG practices or willingness to engage on mitigating key

Sustainability Factors or Sustainability Risks. The fund shall also implement enhanced ESG engagement as part of its stewardship commitment. The ESG evaluation carried out by the fund is part of the wider credit analysis. Input from external ESG information providers may define the specific issuers excluded as part of the ESG screening applied. However, with respect to the ESG evaluation of issuers, data from external ESG information providers is only used as an input and it does not define the ESG risk rating. The fund aims to only invest in fixed income securities which contribute to the attainment of the ESG characteristics promoted by the fund. The fund may use derivatives (such as futures, options and swaps, which are linked to the rise and fall of other assets) to obtain, increase or reduce exposure to underlying assets and may thus create gearing which may result in greater fluctuations of the value of the fund. The manager of the fund will ensure that the use of derivatives does not materially alter the overall risk profile of the fund.

If you hold shares in a class that pays dividends we expect that any income generated by the fund will be paid out to you on a regular basis. For other share classes, any income the fund makes will be reinvested to grow your investment.

You can buy and sell shares every day which is a business day in London and Luxembourg, subject to the terms in the General Information section of the prospectus.

The fund may not be appropriate for investors who plan to invest for less than three years.

Risk and reward profile

The Risk and Reward Indicator table shows where the class ranks in terms of its potential risk and return. The higher the rank the greater the potential reward but the greater the risk of losing money. The table uses a standard calculation method that is used by all companies who offer such funds within the European Union.



The shaded area in the table above shows the class's ranking based on the Synthetic Risk and Reward Indicator. It is based upon how much the price of the class has moved up and down in the past. The class is ranked at 4, which is typically more than a class which invests in straight fixed income because this class may at times use derivatives and leverage in order to achieve a higher level of exposure to market movements, and similar to a class which invests in company shares. Please note that using such past information may not reliably predict how the class will perform in the future. Its ranking is not guaranteed to remain unchanged and may shift over time. Even the lowest risk class does not mean the investment is risk free.

The Risk and Reward Indicator does not take into account the following:

- At times, the market for emerging market bonds may dry up, which could make it difficult to sell these bonds, or the fund may only be able to sell them at a discount
- There may be cases where an organisation with which we trade assets or derivatives (usually a financial institution such as a bank) may be unable to fulfil its obligations, which could cause losses to the fund
- Investing in emerging market bonds offers you the chance to gain higher returns through growing your capital and generating income. Nevertheless, there is a greater risk that the organization which

issued the bond will fail, which would result in a loss of income to the fund along with its initial investment

- BlueBay's ESG analysis can rely on input from external providers. Such data may be inaccurate or incomplete or unavailable and BlueBay could assess the ESG risks of securities held incorrectly
- BlueBay could suffer from a failure of its processes, systems and controls – or from such a failure at an organisation on which we rely in order to deliver our services – which could lead to losses for the fund
- Emerging markets may be more volatile and it could be harder to sell or trade these bonds. There may be less government supervision, legal regulation and less well-defined tax laws and procedures than in countries with more developed trading markets. Emerging markets can be particularly sensitive to political instability, which can result in greater volatility and uncertainty, subjecting the fund to the risk of losses

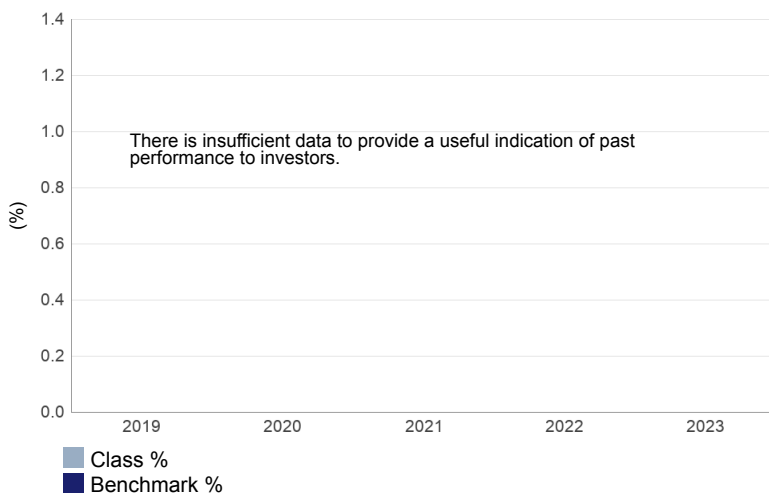
