#### FUND OVERVIEW

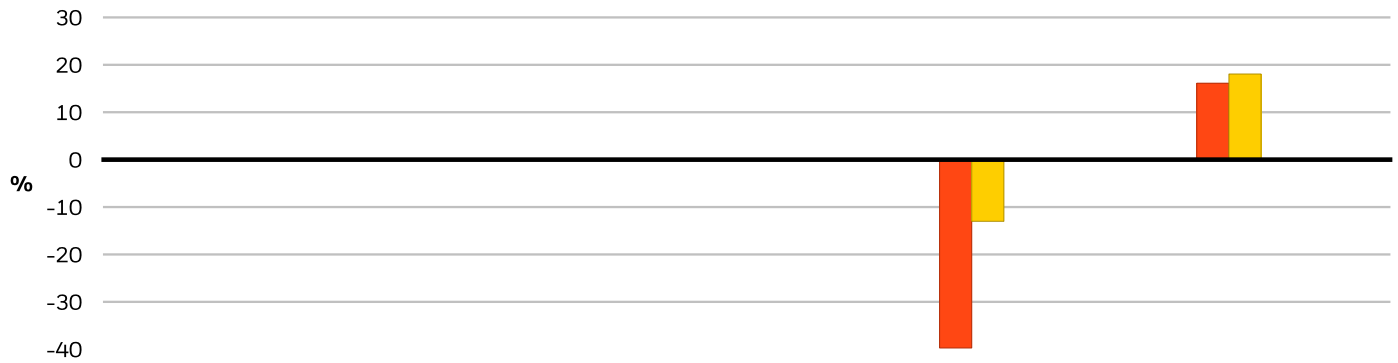

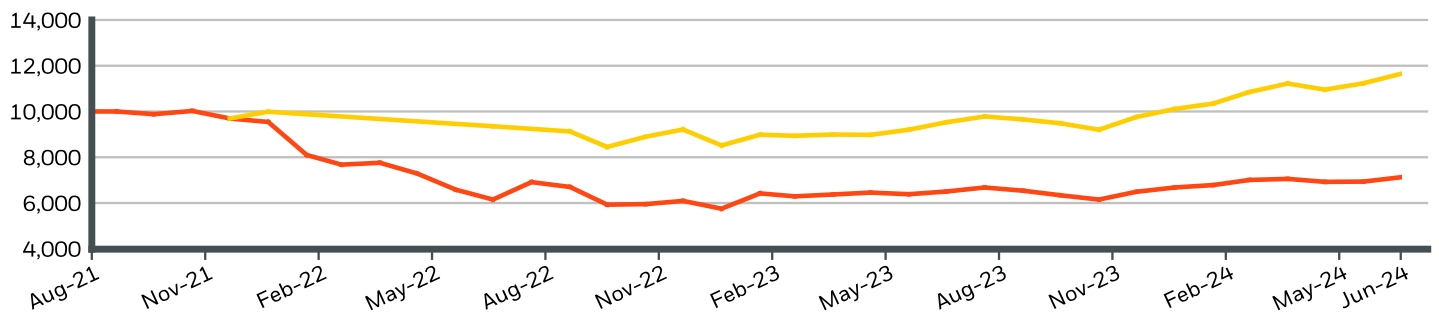

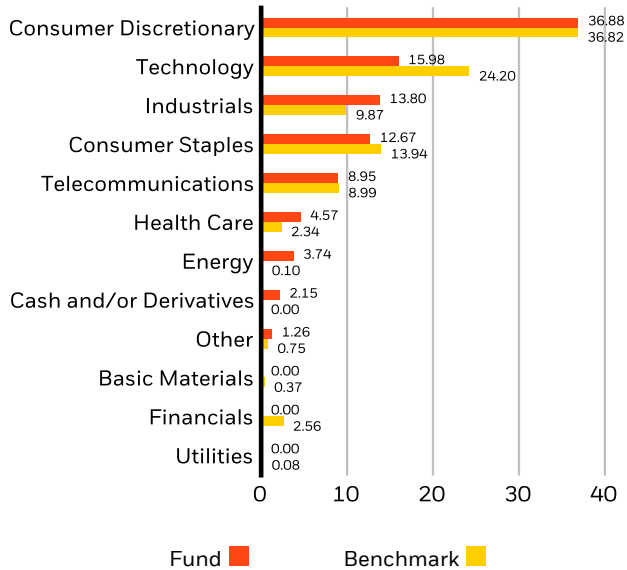

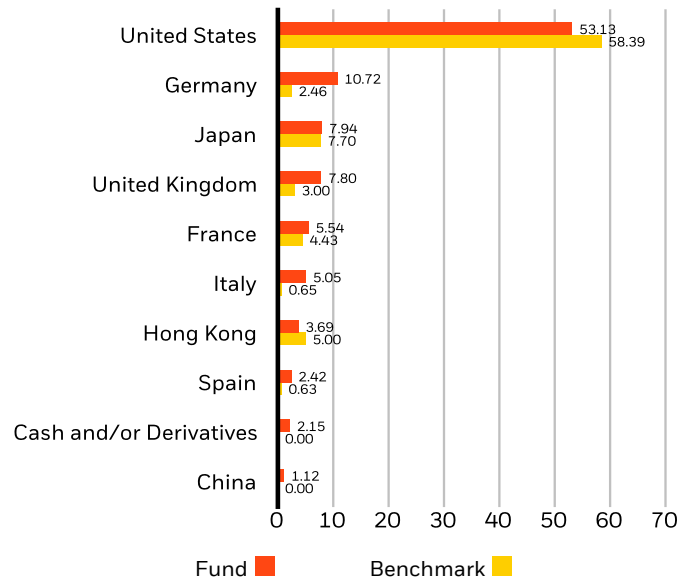

#### SECTOR BREAKDOWN (%)



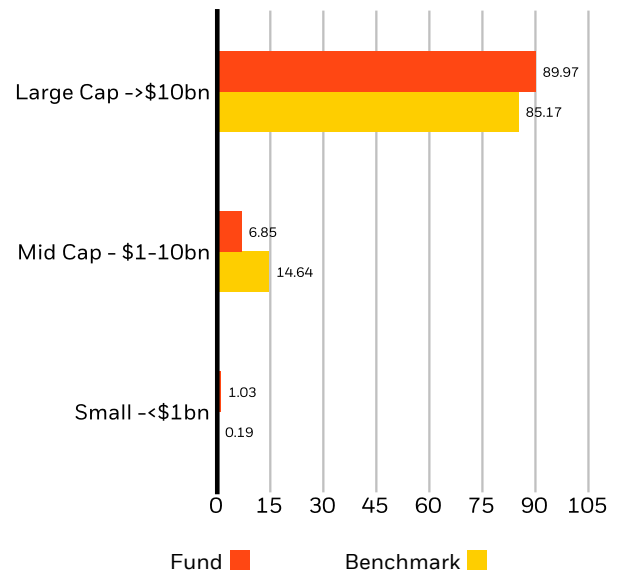
