Objective and investment policy

Objective:

The fund aims to:

- provide a combination of capital growth and income to deliver a return net of the Ongoing Charges Figure that is higher than the MSCI World Index over any five year period; and
- invest in companies that deliver solutions to the challenge of better health and well-being.

Core investment: At least 80% of the fund is invested in the shares of companies, across any sector and of any size, that are based, or do most of their business, in developed markets. The fund may also invest in the shares of emerging market companies. The fund is concentrated and usually holds shares in fewer than 40 companies.

The fund invests in securities that meet the ESG Criteria and Impact Criteria. Norms, sector and/or values-based exclusions apply to investments.

Other investments: The fund may also invest in other funds (including funds managed by M&G) and cash or assets that can be turned into cash quickly.

Derivatives usage: To reduce risk and costs.

Strategy in brief: The fund invests over the long term in companies delivering solutions to better health and well-being based on M&G's proprietary impact assessment methodology alongside a financial return. ESG and impact considerations are fundamental in the stock selection process.

The fund uses the UN Sustainable Development Goals framework, investing in companies focused on areas including health and well-being; zero hunger; clean water and sanitation; sustainable cities and communities; responsible consumption and production.

Benchmark: MSCI World Index

The benchmark is the target against which the fund's financial performance can be measured. The index has been chosen as benchmark as it best reflects the fund's financial objective. The benchmark does not constrain the fund's portfolio construction.

The fund is actively managed. The fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents, and as a result the fund's performance may deviate materially from the benchmark.

For unhedged and currency hedged share classes, the benchmark is shown in the share class currency.

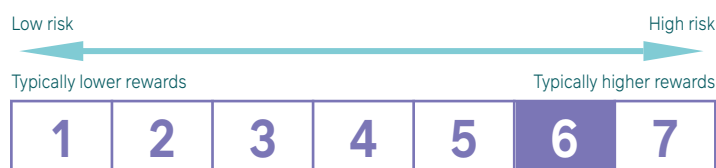
You can buy and sell shares in the fund on any business day. Instructions received before 12 noon will be dealt at that day's price.

Any income from the fund may be paid out to you.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund. These can be higher when investing outside Europe.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

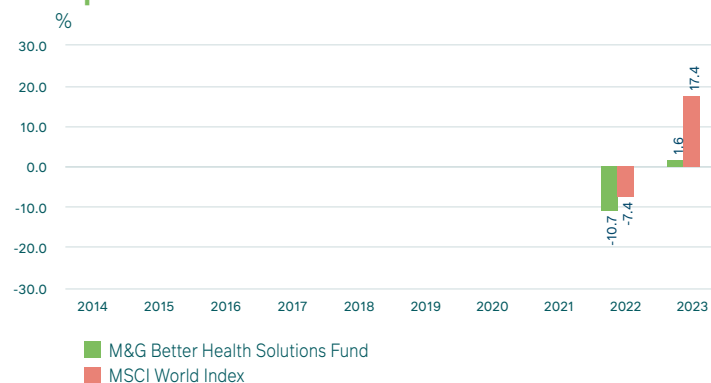
The entry and exit charges shown are the maximum figures and, in some cases, you may pay less. The ongoing charge is based on expenses for the period/year ending 30 September 2023. This figure may change from year to year. It excludes portfolio transaction costs. This figure includes extraordinary expenses and underlying charges for closed-ended-funds, such as investment trusts and Real Estate investment trusts.

For Income shares, the ongoing charge is taken from investments held in the fund's portfolio and not from the income these investments produce. The deduction of this charge will reduce the potential growth of your investment.
