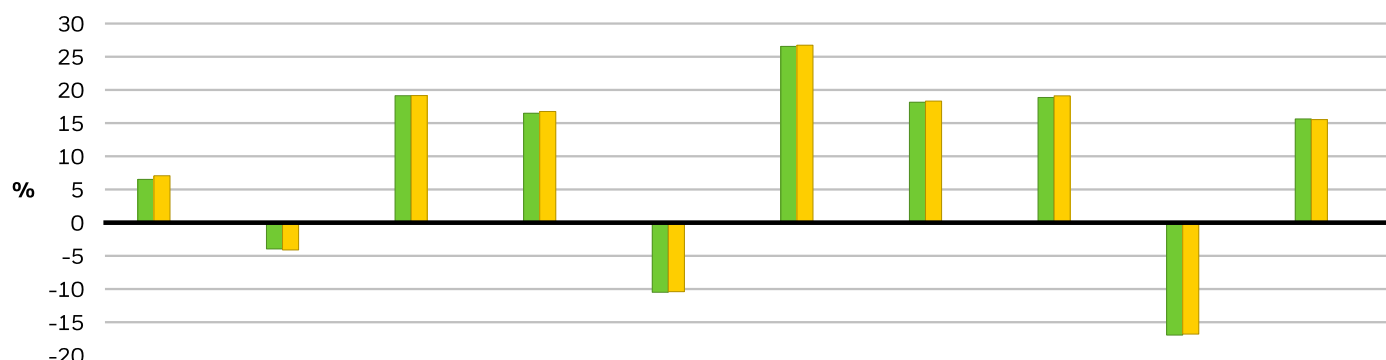

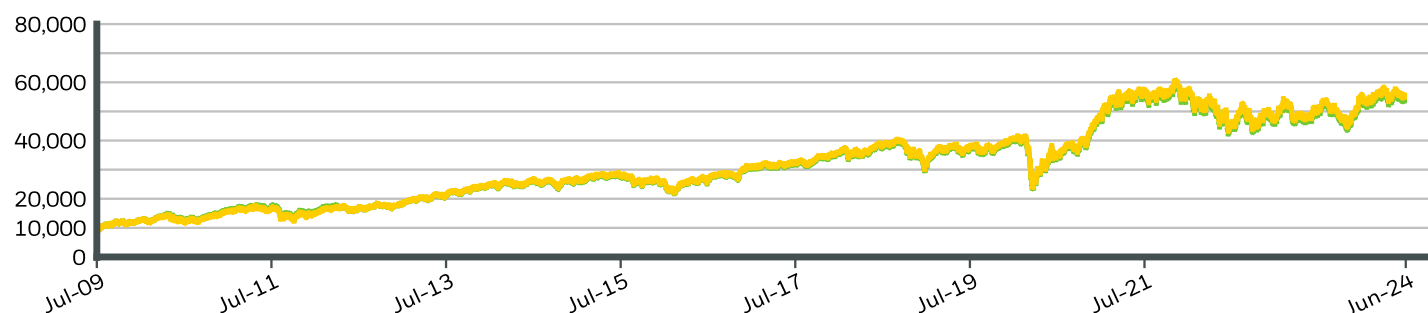

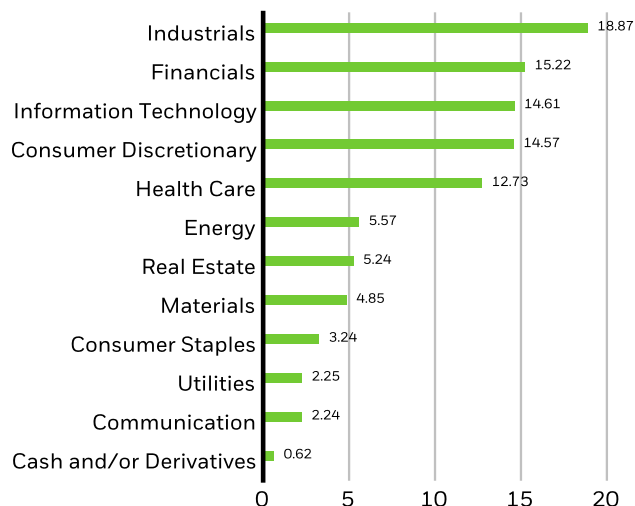

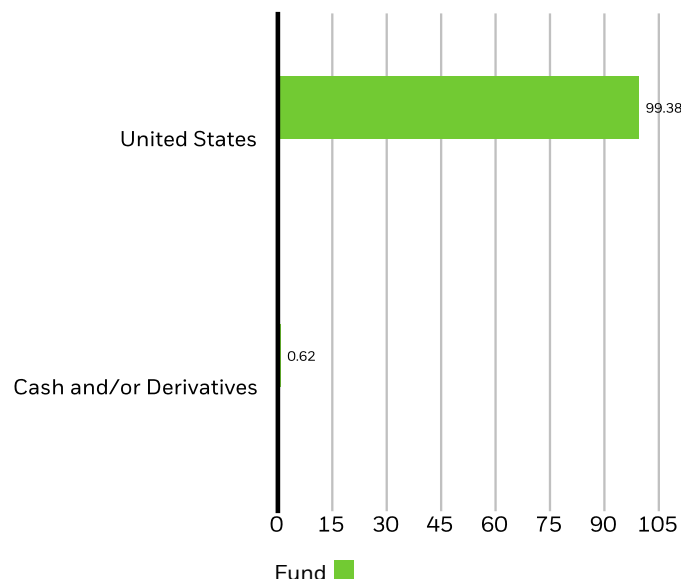
#### SECTOR BREAKDOWN (%)
