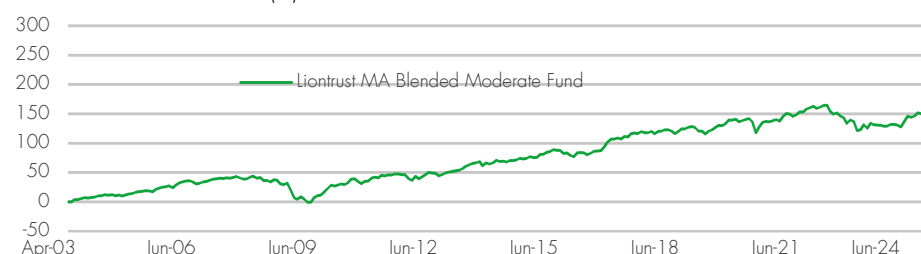
Investment Objective and Policy Summary

The Fund seeks to achieve capital growth and income with a below median level of volatility (risk), having a risk profile of 3, in a range from 1 to 7 where 1 is the lowest risk and 7 the highest. The risk profile used by Liontrust to produce the long term asset allocation differs from the Synthetic Risk and Reward Indicator shown elsewhere in this document, so the two rankings may not be the same. The Fund is an actively managed fund of funds which invests at least 70% of its assets in other funds (underlying funds), including those traded on stock exchanges, other closed-ended funds and funds managed by Liontrust or its associates. The underlying funds will invest in a range of asset classes including shares, bonds, money market instruments, freely transferable rights to buy other investments at a future

date (warrants), financial contracts that derive their value from other investment instruments or indices (derivatives) and deposits. The underlying funds will be a blend of 'active' funds which aim to beat the performance of a benchmark and 'passive' funds, which aim to track the performance of an index. The Fund may also invest directly in the above asset classes. The Fund may invest indirectly in property through Real Estate Investment Trusts and shares in property investment companies. The Fund aims to take a below median level of risk. Liontrust selects investments for the Fund according to its long-term asset allocation based on its risk profile. Liontrust may change the combination of assets for the Fund over the short to medium term where it sees a benefit in doing so, as long as its overall long-term risk profile remains similar.

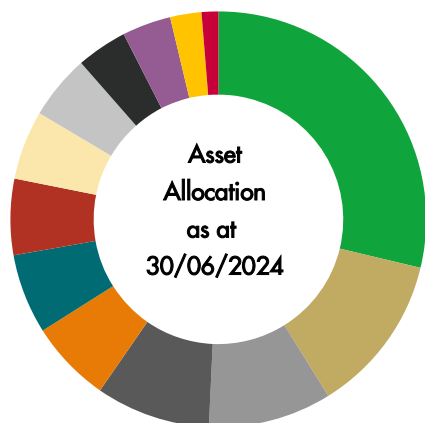

If this is the case, Liontrust will pay the difference from its own resources. Conversely, in some periods, the Administration Fees may be higher than the Operating Expenses, in which case Liontrust will retain the difference. As the funds in which you are invested grow in assets, the fixed Administration Fees are reduced.
