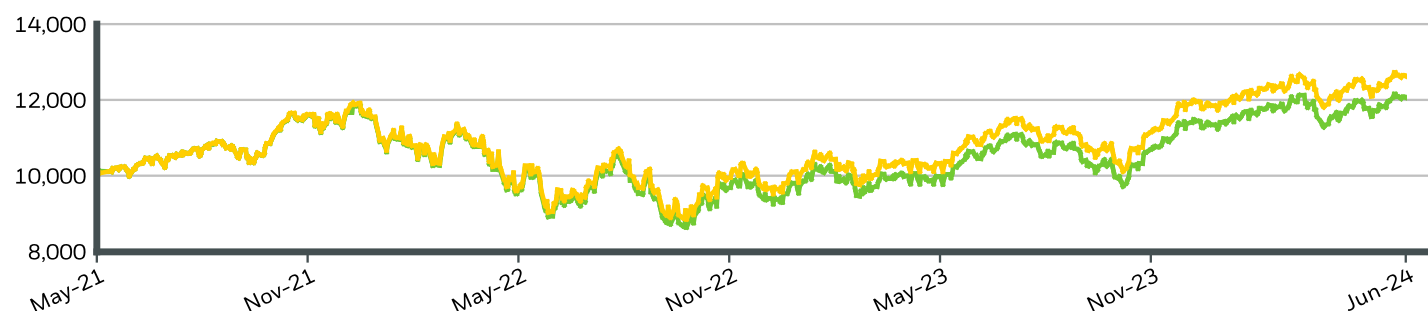

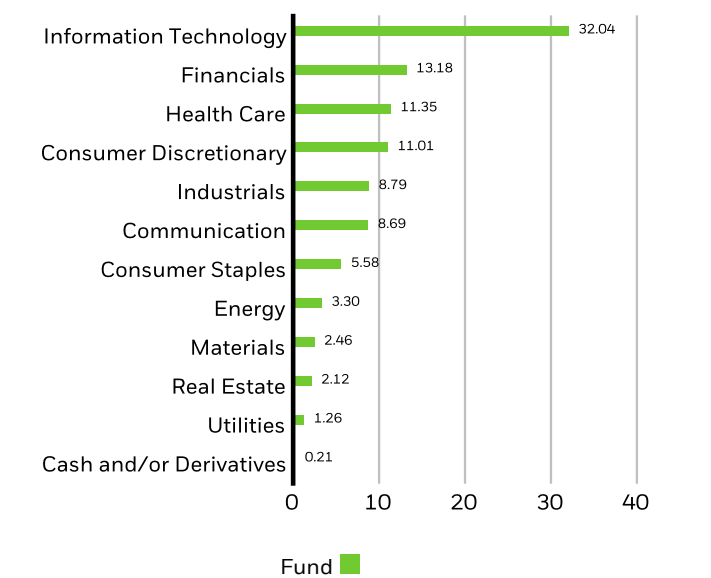

SECTOR BREAKDOWN (%)

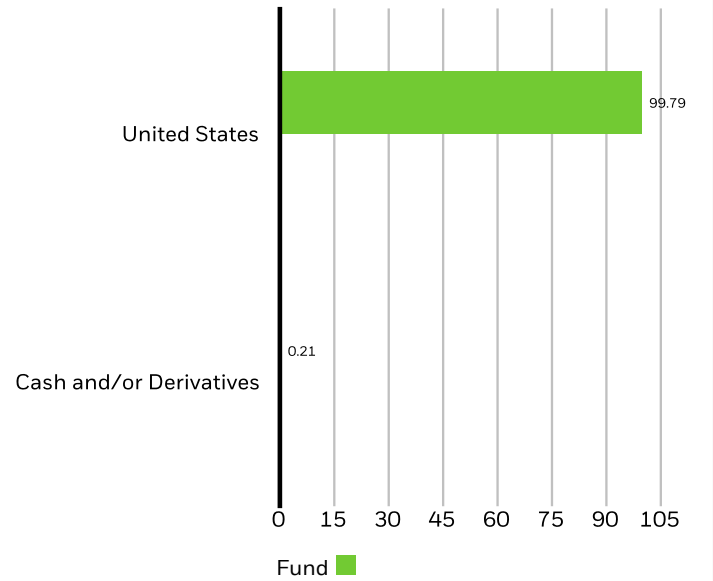
