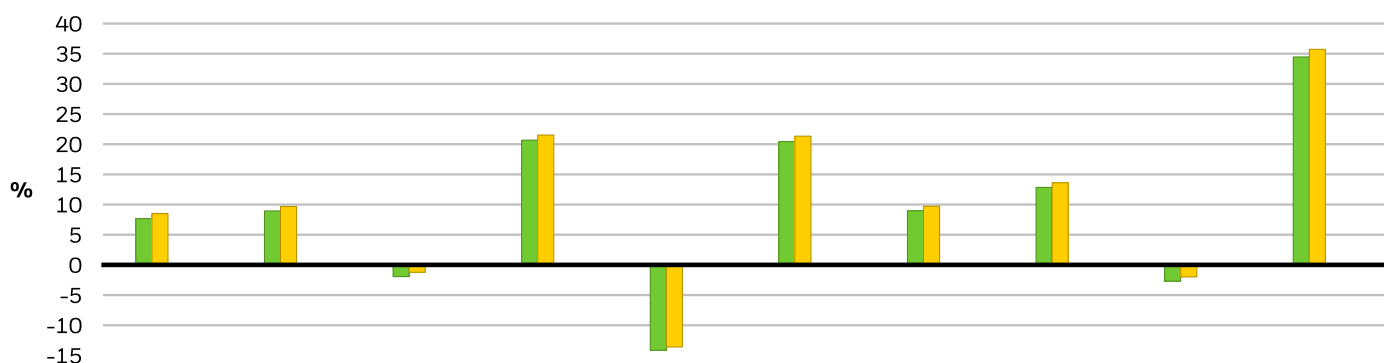

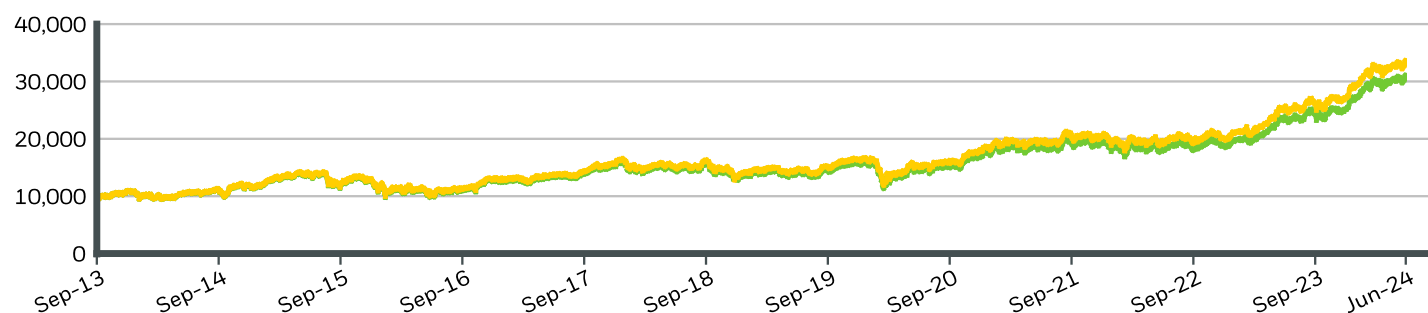

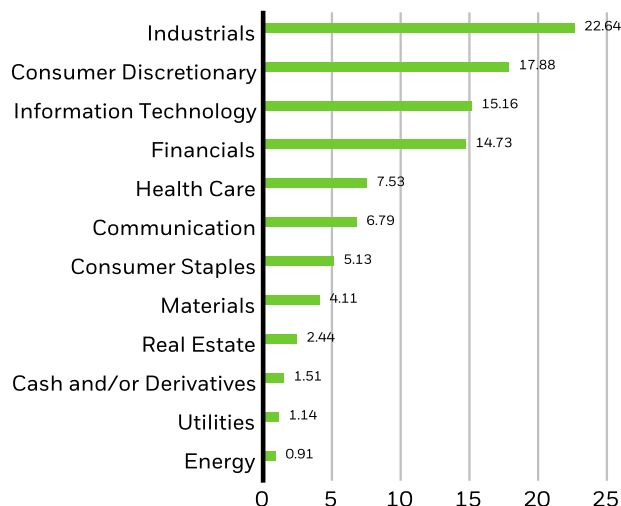

SECTOR BREAKDOWN (%)



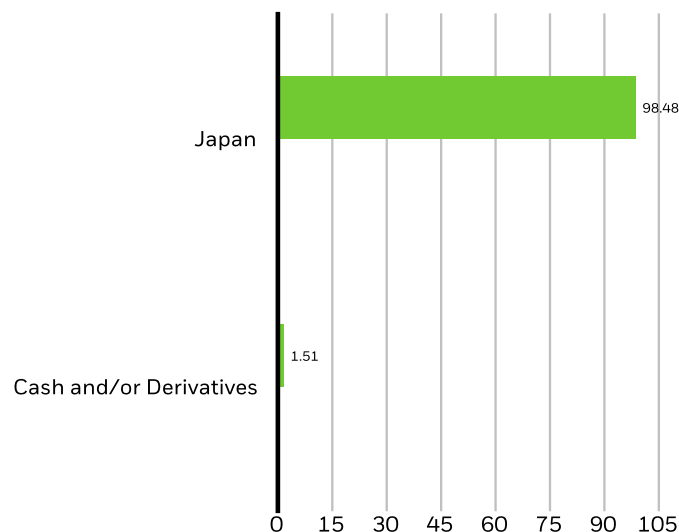

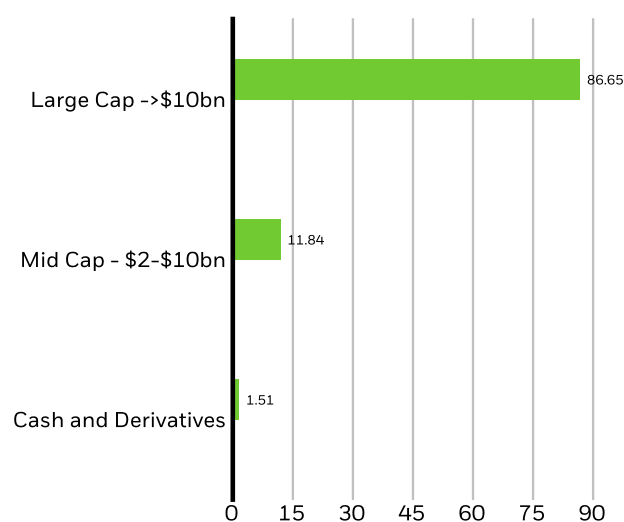
GEOGRAPHIC BREAKDOWN (%)
