FUND OVERVIEW

- The Fund invests at least 70% of its total assets in the equity securities (e.g. shares) of companies incorporated or listed in the United Kingdom.

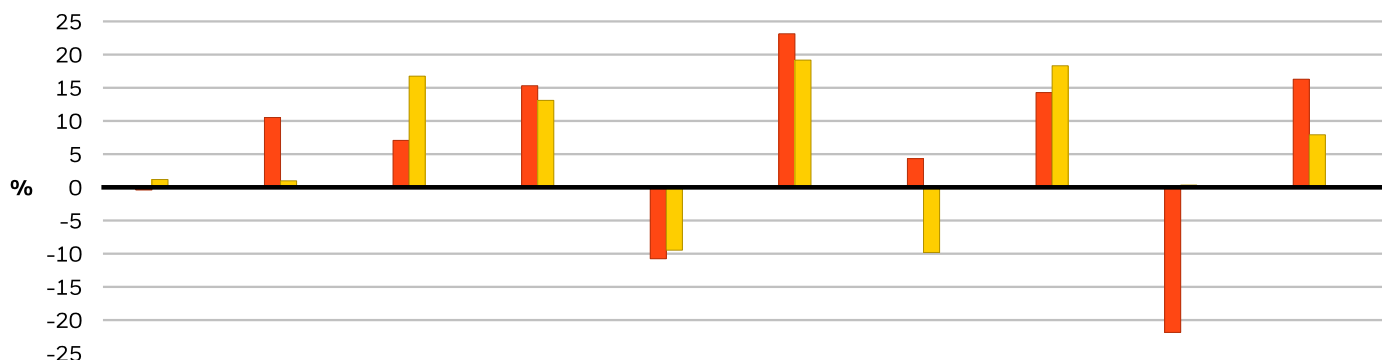

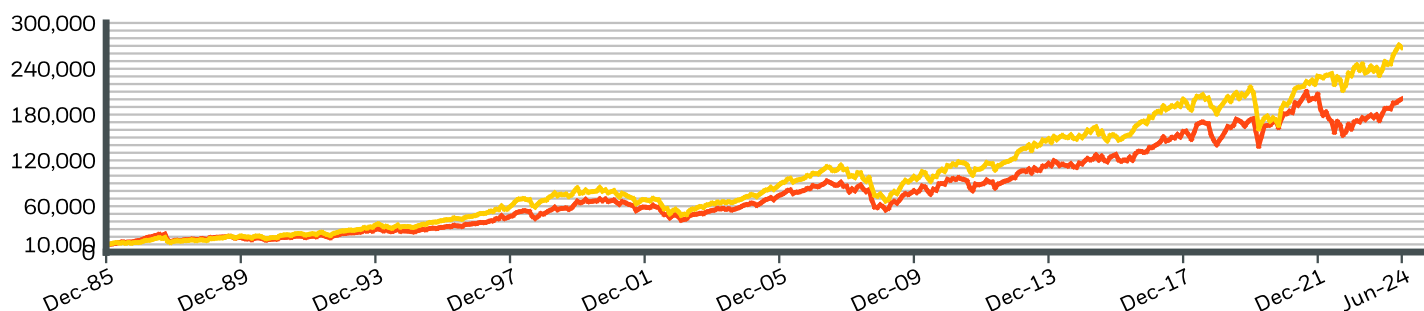

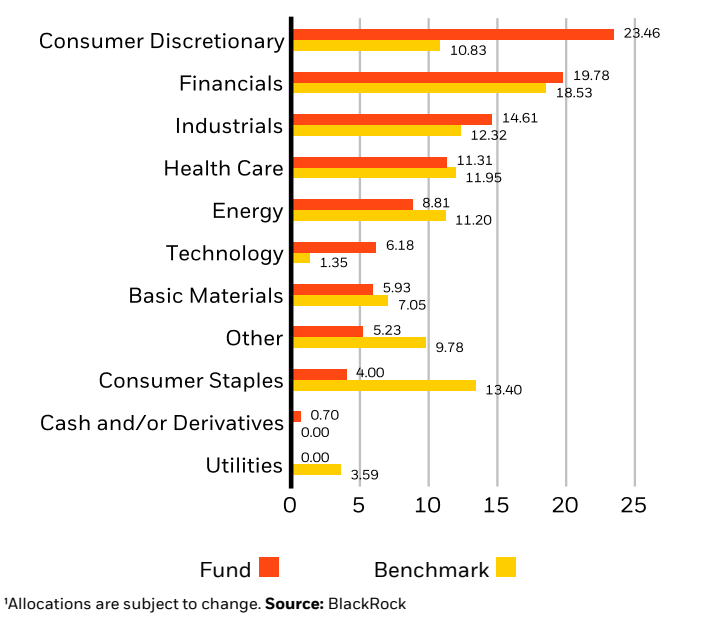

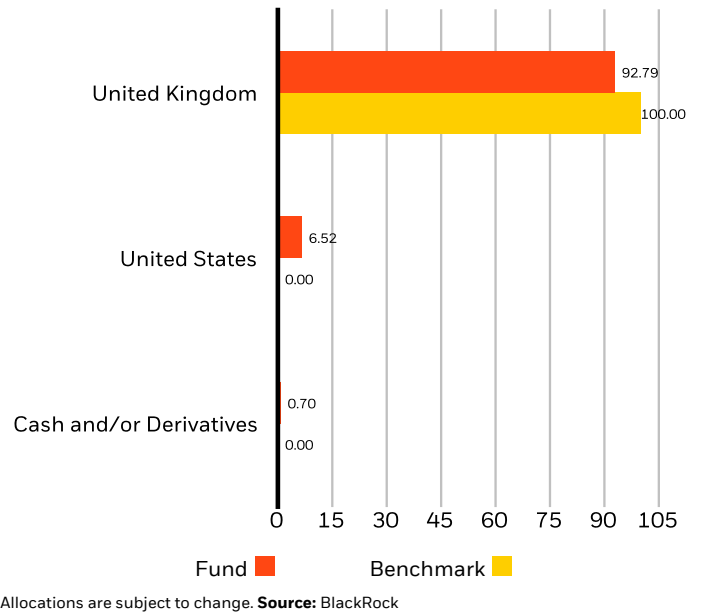

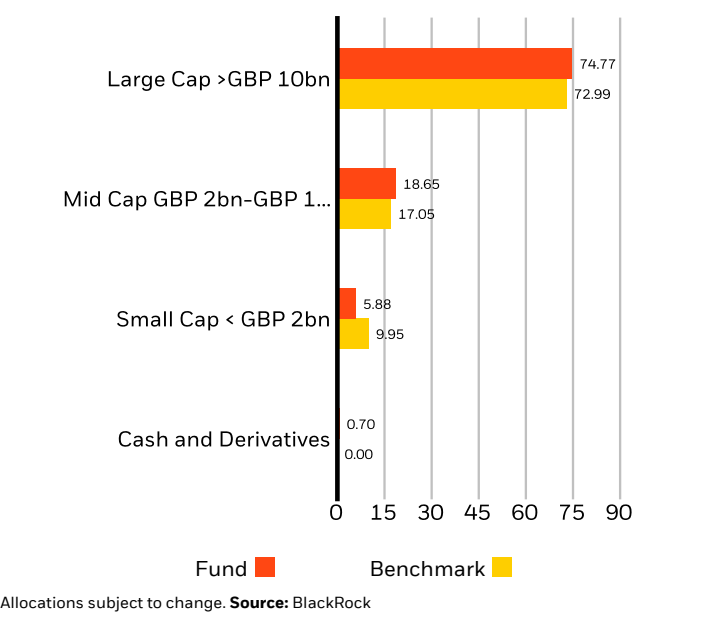
SECTOR BREAKDOWN (%)
