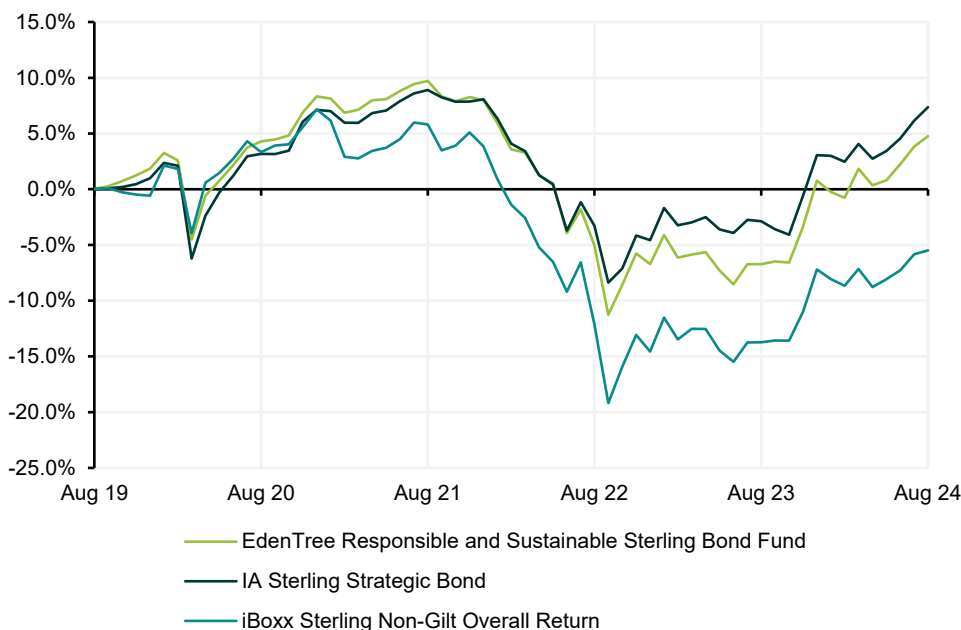

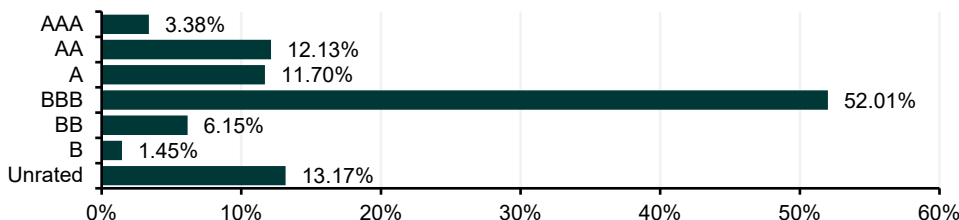

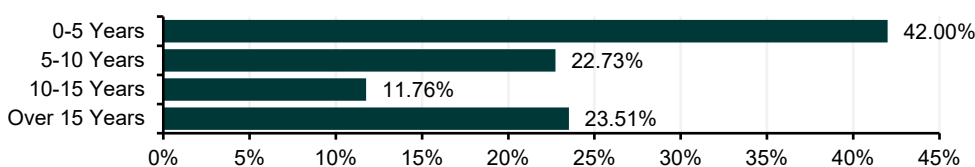

Bond Maturity



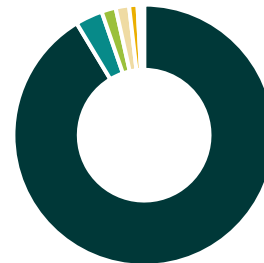
