

# FSSA Asia All-Cap Fund Class B GBP

## Investment objective and policy

The Fund aims to achieve capital growth over the medium to long term (at least three years).

The Fund invests at least 80% in shares of companies based in or where the majority of their activities take place in the Asia Pacific region (excluding Japan) and are listed on exchanges worldwide. This includes companies that are listed on exchanges worldwide which provide exposure to the Asia Pacific region (excluding Japan). The Fund may also invest up to 20% in shares of companies around the world. The Fund may invest up to 10% in other funds.

The Fund will only use derivatives to reduce risk or to manage the Fund more efficiently in limited cases.

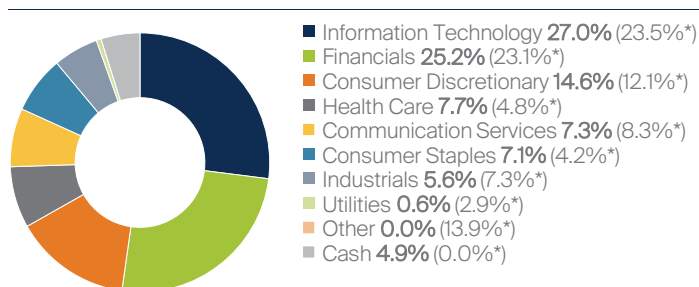

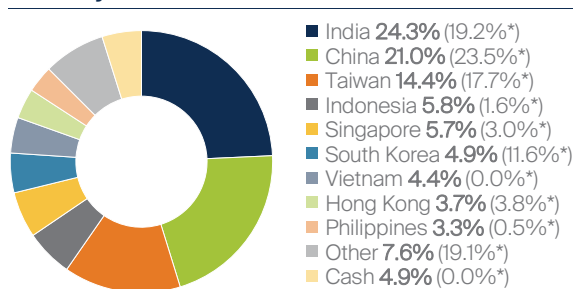
