Objective

To generate growth over the long term (5 years or more) by investing in UK small-capitalisation equities (company shares).


Performance Target: To achieve the return of the Deutsche Numis Smaller Companies Plus AIM ex Investment Companies Index plus 3% per annum (before charges). There is no certainty or promise that they will achieve the Performance Target.

Performance Comparator: Investment Association UK Smaller Companies Equity Sector Average. The Deutsche Numis Smaller Companies Plus AIM ex Investment Companies Index (the "Index") is a representative index of the UK stock market of smaller companies.

Portfolio securities

- The fund will invest at least 60% in equities of UK smaller companies.
- UK smaller companies are defined as any company of a similar size to those in the Index.
- The fund may also invest up to 40% in larger UK companies.
- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.


