### **FUND MANAGER**



Stephen Ackerman has been a deep value income focused investment manager for over 22 years and has managed the Castellain Income Fund since inception.

#### **COMMENTARY**

The Income Fund was up 0.9% during June and is up 4.9% year to date.

HarbourVest, as referenced here last month as the Fund's largest holding, has been topsliced after an inter-month share price increase of 10%. These shares continue to trade on a share price discount to net asset value of 40%.

The Fund's 4% position in Regional REIT bonds has enjoyed a strong month after the company successfully announced its medium term funding plans.

Elsewhere, the Fund received modest capital returns proceeds from two of the Fund's credit related investments.


## **INVESTMENT OBJECTIVE**
