

# KEY INVESTOR INFORMATION

This document provides you with key investor information about this fund. It is not marketing material. The Company is managed by PGIM Investments (Ireland) Limited, part of the PGIM group of companies.

## Objectives and Investment Policy

The Fund seeks long-term capital appreciation. There can be no assurance that the investment objective will be achieved. The Fund will seek to achieve its investment objective by investing in equity and equity-related securities of companies located around the world that the Sub-Investment Manager believes are involved in activities that will reduce global carbon emissions and aid in the transition to a clean energy future.

The benchmark of the Fund is the MSCI ACWI IMI (All Country World Investable Market Index) (the “Benchmark”); however, the Sub-Investment Manager has discretion over the investments of the Fund. The Fund will be actively managed and does not intend to track the Benchmark. The Benchmark is being used by the Fund for performance comparison purposes only.

The Sub-Investment Manager looks for companies that it believes contribute towards the clean energy transition through areas such as fuel decarbonisation, carbon capture and storage, electrification, renewables, infrastructure modernisation, and energy efficiency. The Fund may invest in companies that the Sub-Investment Manager believes will support improved sustainability practices over time, such as natural gas companies.

The Fund may invest in securities of issuers of any market capitalisation size. The Fund can invest without limit in non-U.S. equity and equity-related securities, typically invests in a number of different countries, and may invest a significant portion of its assets in companies located in emerging markets. The Fund may also invest in China A Shares through the Shanghai–Hong Kong Stock Connect and Shenzhen–Hong Kong Stock Connect programs.

The Fund may also hold cash, on an ancillary basis, and invest in money market instruments, which may comprise fixed term deposits, fixed and floating rate instruments including (but

not limited to) certificates of deposit, banker acceptances, freely transferable promissory notes, commercial paper, floating rate notes, debentures, asset-backed commercial paper, government bonds, corporate bonds, asset-backed securities and money market funds. The Fund may not be leveraged in excess of 100% of its net asset value, through the use of derivatives.

The Fund promotes the reduction of carbon emissions (a sustainability characteristic) through its incorporation of environmental, social and governance (“ESG”) factors into its investment process and is therefore classified under Article 8 of the Sustainable Finance Disclosure Regulation (“SFDR”). The Fund does not invest in companies listed on certain exclusion lists published by third parties and based on ESG considerations, as detailed in the Supplement. Although the Fund promotes a sustainability characteristic, it does not have sustainable investment as its investment objective.

All net investment income, if any, will be declared as dividends. Net realised gains attributable to the distribution class shares are expected to be retained by the Fund.

Portfolio transaction costs, which are paid by the Fund in addition to the costs set out under “Charges” below, may have a material impact on the performance of the Fund.

Investors can buy and sell their shares on each business day of the Fund.

The Fund may not be appropriate for investors who plan to sell their shares within the short term.

The shares are denominated in British Pounds. The base currency of the Fund is the US Dollar.

**Currency Risk:** The value of the investments of the Fund designated in another currency may rise and fall due to exchange rate fluctuations.

**Custodial Risk:** Assets which are traded in markets where custodial and/or settlement systems are not fully developed, may be exposed to risk in circumstances where the custodian will have no liability.

**Emerging Market Risk:** The Fund invests in emerging markets, which may experience political, market, social, regulatory, and/or economic instabilities. These instabilities may

reduce the value of the Fund’s investments.

**Market Risk:** Investments are subject to normal market fluctuations and the risks inherent in investment in international securities markets.

**Political Risk:** The value of the Fund’s investments may be affected by uncertainties such as international policy developments and changes in government policies. This can result in more pronounced risks where conditions have a particular impact on one or more countries or regions.

**Principal Investment Strategies:** There are risks associated with the Fund’s principal investment strategies, including that because the Fund may invest a large portion of its assets in a single country or region of the world, the Fund’s investments may be geographically concentrated, which can result in more pronounced risks based upon economic conditions that impact one or more countries or regions.

**Socially Responsible Investment Risk:** The Fund may achieve lower returns than an equivalent fund which does not pursue a socially responsible mandate.

## Charges
