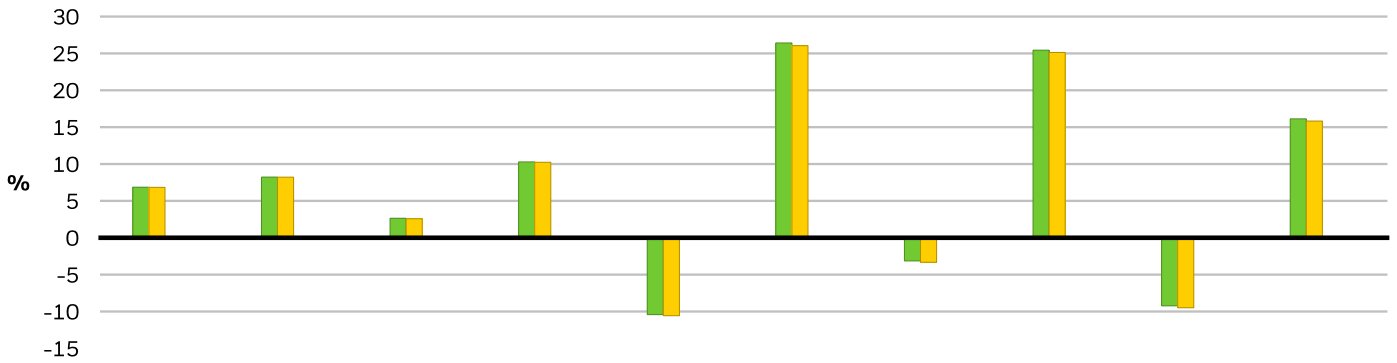

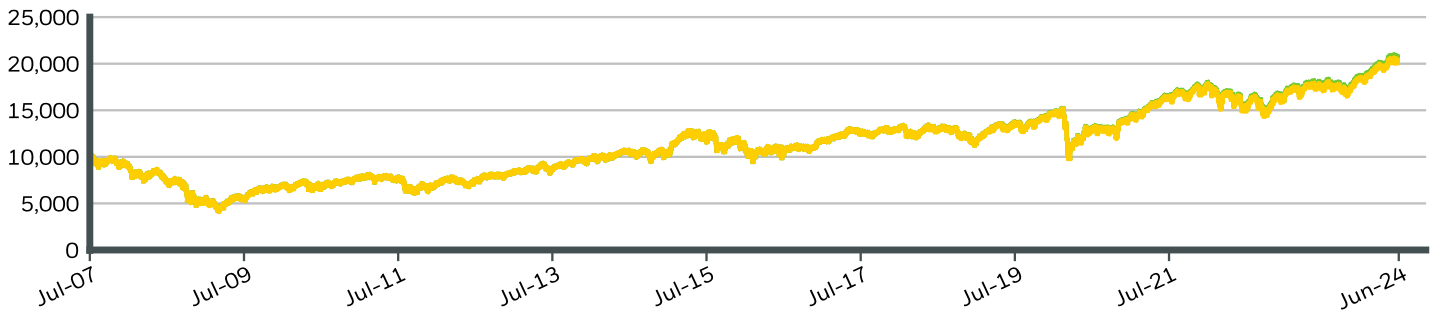

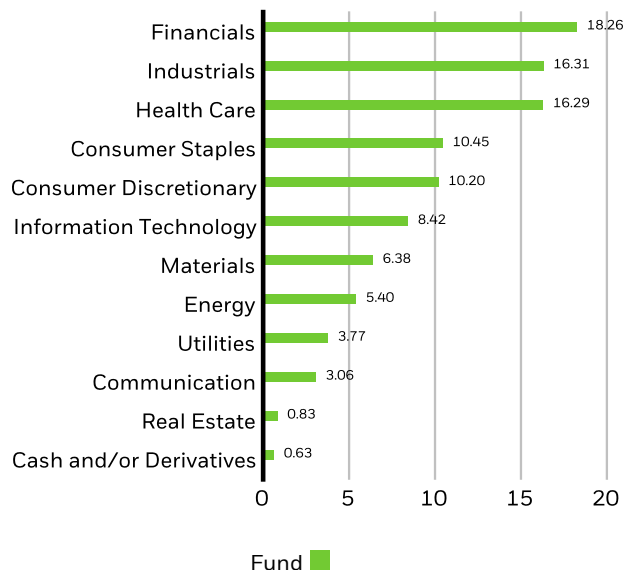

#### SECTOR BREAKDOWN (%)



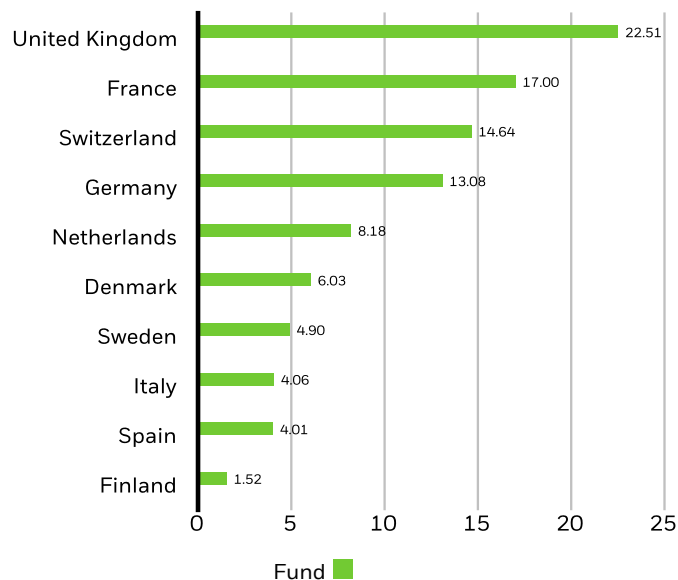

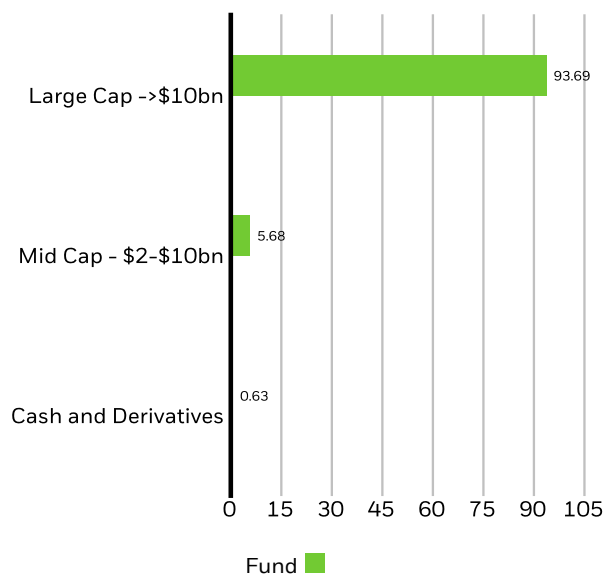
