## Objective

To generate growth over the long term (5 years or more) by investing in Asia Pacific, excluding Japan equities (company shares).

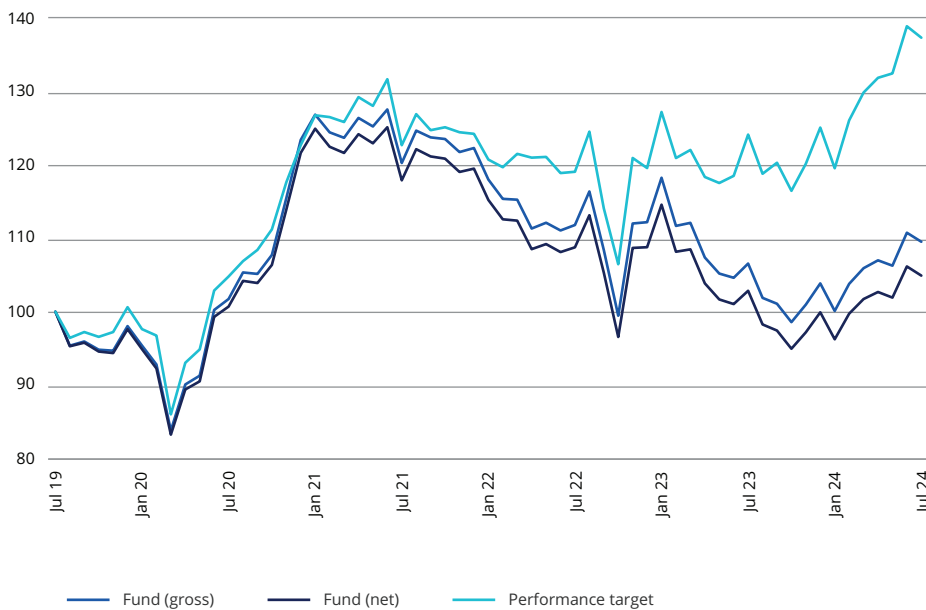

## Portfolio securities

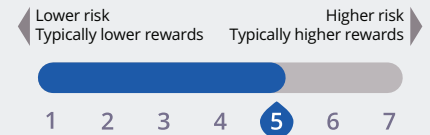

## Derivative usage
