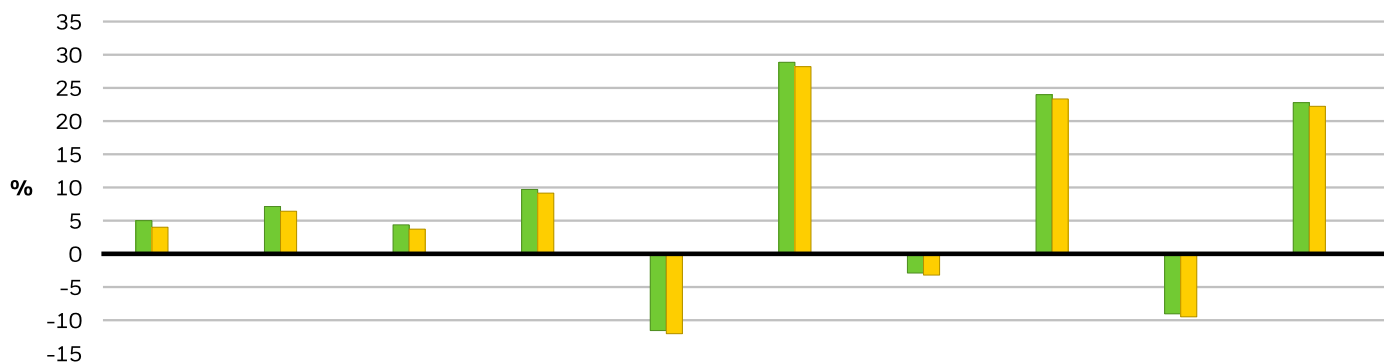

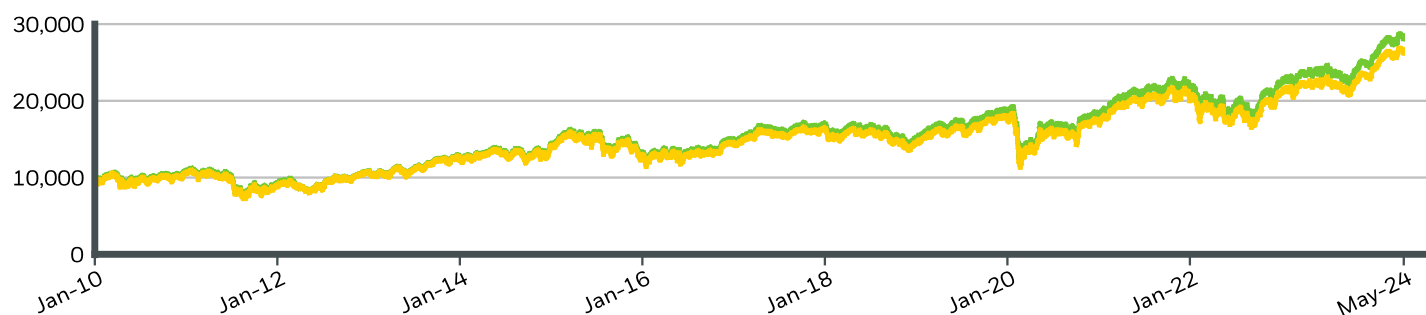

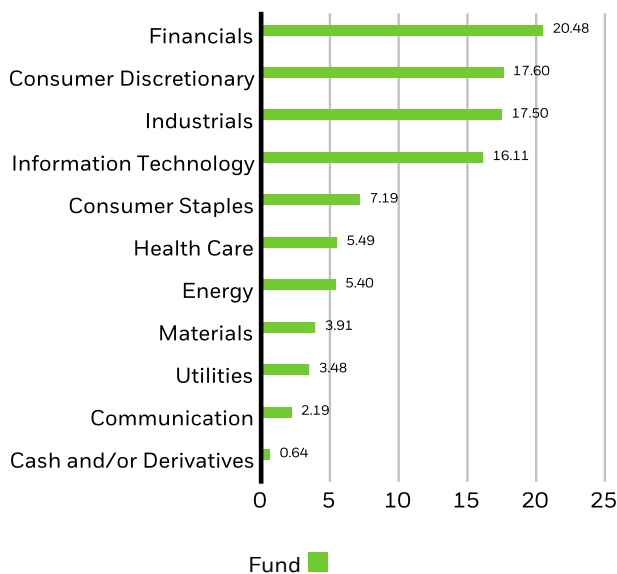

SECTOR BREAKDOWN (%)



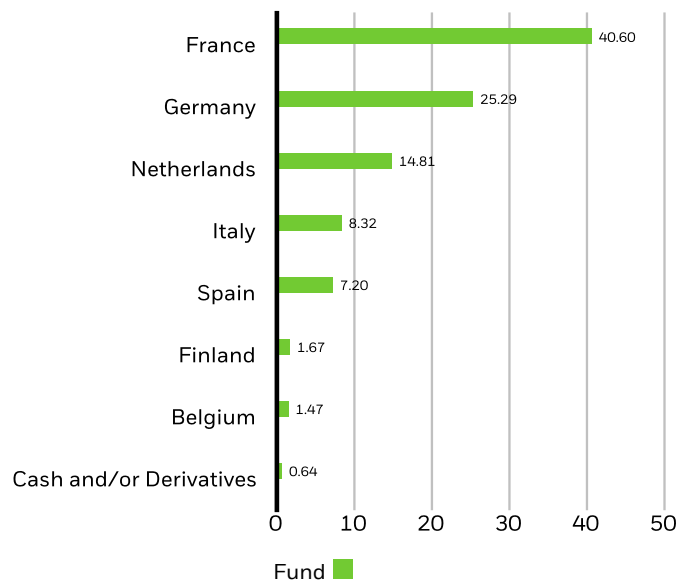

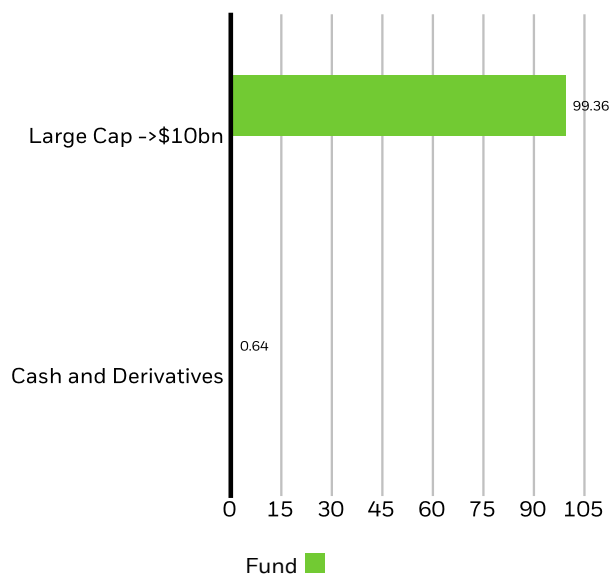
