Objectives and Investment Policy

Objective: The fund aims to achieve capital growth long term.

Investment Policy: The fund invests at least 70% (and normally 75%) of its assets, in equities of companies that are listed, headquartered or do most of their business in Asia (excluding Japan), including emerging markets. The fund will have a mixture of investments in larger, medium and smaller sized companies. The fund will seek opportunities in special situations equities (which are shares in companies that generally have attractive valuations in relation to net assets or earning potential) and/or companies which are undervalued and whose recovery potential is not recognised by the market.

The fund may also invest in money market instruments on an ancillary basis. The fund invests at least 50% of its assets in securities companies with favourable environmental, social and governance (ESG) characteristics.

The fund may invest in the following assets according to the percentages indicated:

China A and B shares (directly and/or indirectly): less than 30% (in aggregate)

SPACs: less than 5%.

Investment Process: In actively managing the fund, the Investment Manager considers the durability of long-term growth prospects that are not fully reflected in current valuations. This includes a focus on special situations such as merger, acquisition and internal restructuring activity, that may affect company's valuations in the short-term. The Investment Manager also considers ESG characteristics when assessing investment risks and opportunities. In determining favourable ESG characteristics, the Investment Manager takes into account ESG ratings provided by Fidelity or external agencies. Through the investment management process the Investment Manager aims to ensure that investee companies follow good governance practices.

The fund adheres to the Fidelity Sustainable Investing Framework standards. For more information, see "Sustainable Investing and ESG Integration" and the Sustainability Annex.

Derivatives and Techniques: The fund may use derivatives for hedging and for efficient portfolio management.

Base Currency: USD

Benchmark: MSCI AC Asia ex Japan Index, an index that does not take into account ESG characteristics. Used for: investment selection, risk monitoring, and performance comparison.

Risk Management Method: Commitment.

Distribution: Income earned by the fund is reinvested in additional shares or paid to shareholders on request.

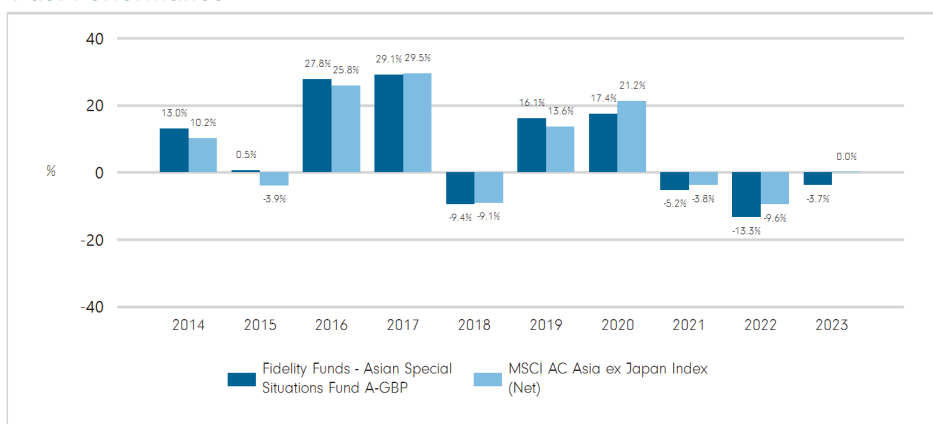
