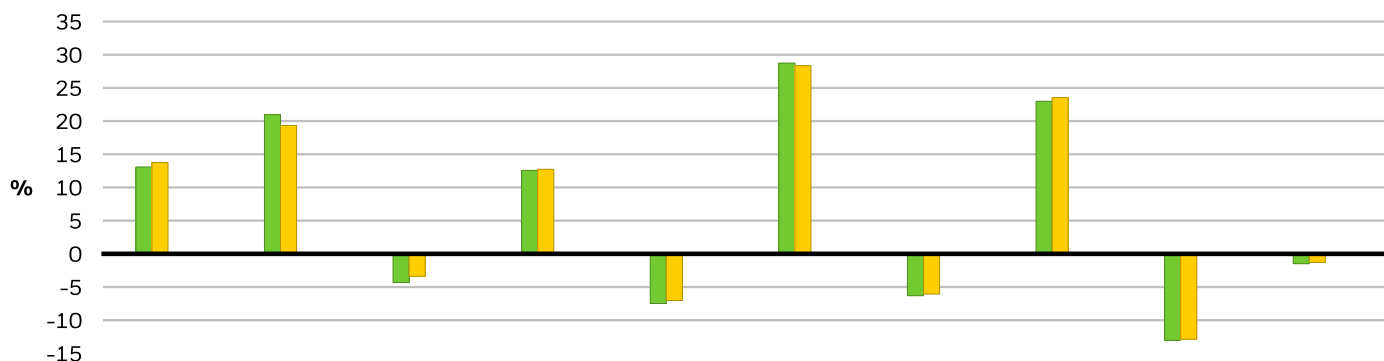

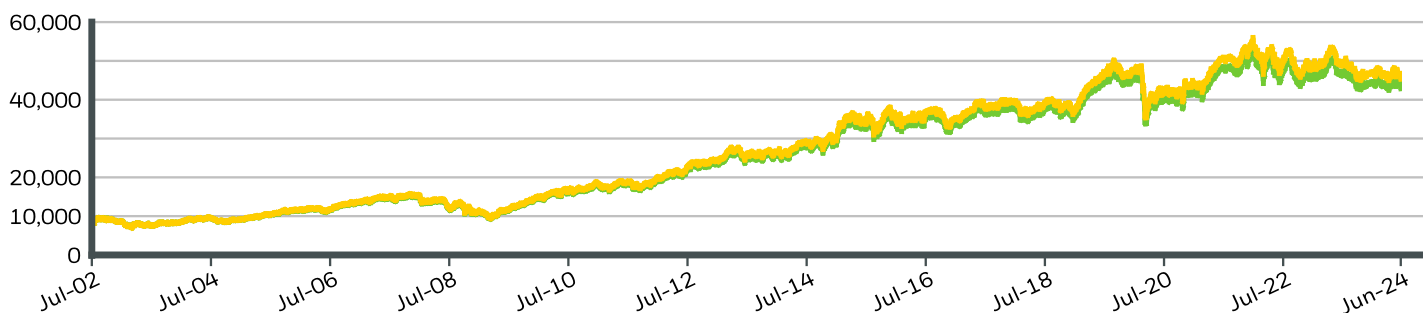

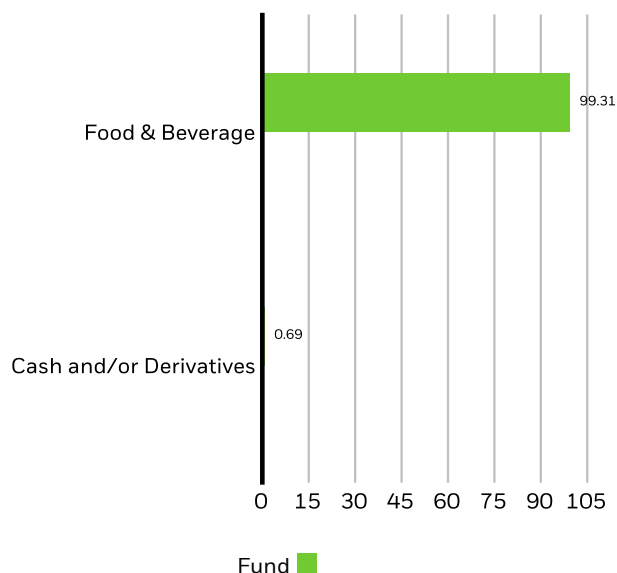

SECTOR BREAKDOWN (%)

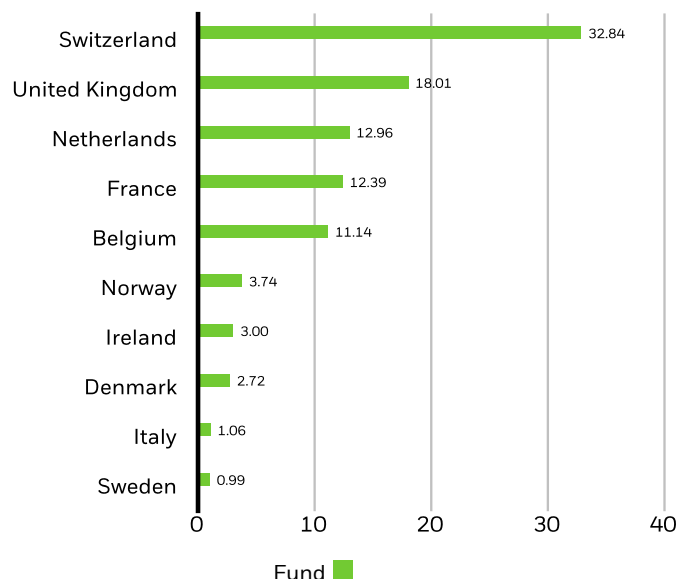
