

# KEY INVESTOR INFORMATION

This document provides you with key investor information about this fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this fund. You are advised to read it so that you can make an informed decision about whether to invest.

The Company is managed by PGIM Investments (Ireland) Limited, part of the PGIM group of companies.

## Objectives and Investment Policy

The Fund seeks long-term growth of capital. The Fund seeks to achieve its objective by investing primarily in equity and equity related securities of companies located around the world.

The benchmark of the Fund is the MSCI ACWI (All Country World Index) (the “Benchmark”), however, the Sub-Investment Manager has discretion over the investments of the Fund. The Fund will be actively managed and does not intend to track the Benchmark. The Benchmark is being used by the Fund for performance comparison purposes only. The Fund’s investment ideas are generated by the investment team’s research analysts, as well as by a screen that identifies companies with fundamental characteristics the team believes will contribute to longer-term performance. Companies identified in the initial research and screening process become the focus of rigorous research, which focuses on three primary areas: competitive position, ability to execute business strategy, and valuation.

The Fund promotes sustainability characteristics through its incorporation of environmental, social and governance (“ESG”) factors into its investment process and is therefore classified under Article 8 of the Sustainable Finance Disclosures Regulation (“SFDR”). The Fund seeks to maintain a weighted average carbon intensity that is at least 50% lower than that of the Fund’s benchmark.

The Fund can invest without limit in non-U.S. equity and equity-related securities, typically invests in a number of different countries, and may invest a significant portion of its assets in companies located in emerging markets. The Fund will not invest more than 50% of its

net asset value in the Taiwan securities market. The Fund may invest in securities of issuers of any market capitalisation size without particular focus on any one sector.

The Fund may also hold cash, on an ancillary basis, and invest in money market instruments and may invest its cash balances in regulated money market or short term bond funds.

The Fund may not be leveraged in excess of 100% of its net asset value, through the use of derivatives.

The Fund does not invest in companies listed on certain exclusion lists published by third parties and based on ESG considerations, as detailed in the Supplement.

All net investment income, if any, will be declared as dividends. Net realised gains attributable to the distribution class shares are expected to be retained by the Fund.

Portfolio transaction costs, which are paid by the Fund in addition to the costs set out under “Charges” below, may have a material impact on the performance of the Fund.

Investors can buy and sell their shares on each business day of the Fund.

The Fund may not be appropriate for investors who plan to sell their shares within the short term.

The shares are denominated in British Pounds. The base currency of the Fund is the US Dollar.

The Fund’s risk category of 6 has been calculated using simulated historical data which may not be a reliable indicator of the Fund’s future risk profile.

The risk rating of the Fund is calculated using a standard methodology used by all UCITS funds, and shows where the Fund ranks in terms of its relative risk and potential return based on past share price fluctuation. Below are certain risks that you should be aware of that may result in a loss or reduction in the value of your investments. These risks are not exhaustive. Potential investors should consult the prospectus and their professional advisers before investing in the Fund.

**Currency Risk:** The value of the investments of the Fund designated in another currency may rise and fall due to exchange rate fluctuations.

**Custodial Risk:** Assets which are traded in markets where custodial and/or settlement systems are not fully developed, may be exposed to risk in circumstances where the custodian will have no liability.

**Emerging Market Risk:** The Fund invests in emerging markets, which may experience political, market, social, regulatory, and/or economic instabilities. These instabilities may reduce the value of the Fund’s investments.

**Growth Style Risk:** The Fund’s growth style may subject the Fund to above average fluctuations. There is the risk that the growth investment style may be out of favour for a period of time, and when the style is out of favour the Fund may underperform the market in general.

**Market Risk:** Investments are subject to normal market fluctuations and the risks inherent in investment in international securities markets.

**Political Risk:** The value of the Fund’s investments may be affected by uncertainties such as international policy developments and changes in government policies. This can result in more pronounced risks where conditions have a particular impact on one or more countries or regions.

**Principal Investment Strategies:** There are risks associated with the Fund’s principal investment strategies, including that because the Fund may invest a large portion of its assets in a single country or region of the world, the Fund’s investments may be geographically concentrated, which can result in more pronounced risks based upon economic conditions that impact one or more countries or regions.

**Socially Responsible Investment Risk:** The Fund may achieve lower returns than an equivalent fund which does not pursue a socially responsible mandate.

## Charges

The charges you pay are used to pay the costs of the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

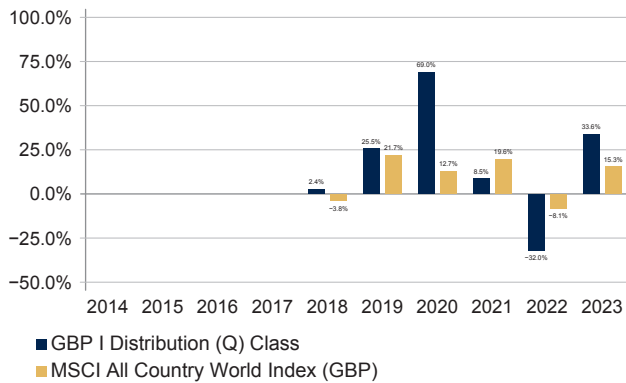

Shareholders may request the exchange of their shares in the Fund for shares of another sub-fund of the Company, as set out under "Conversion of Shares" in the prospectus.
