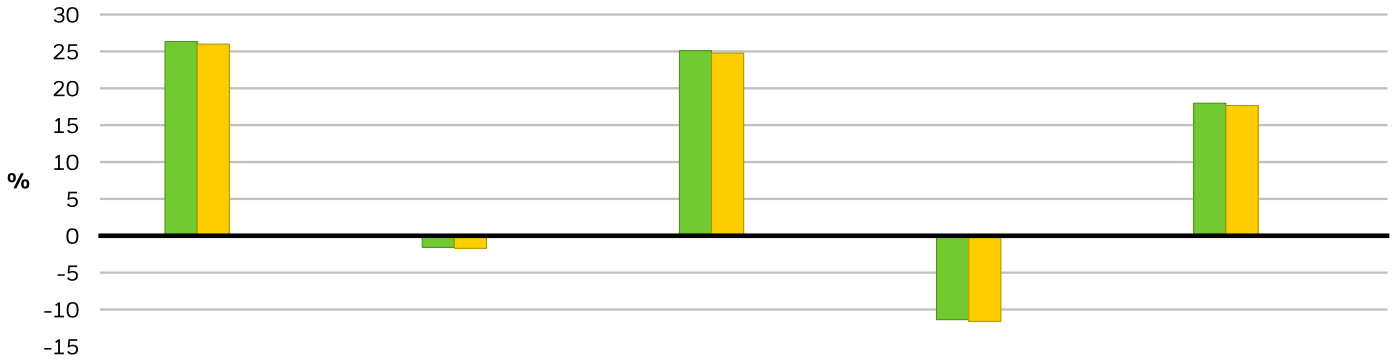

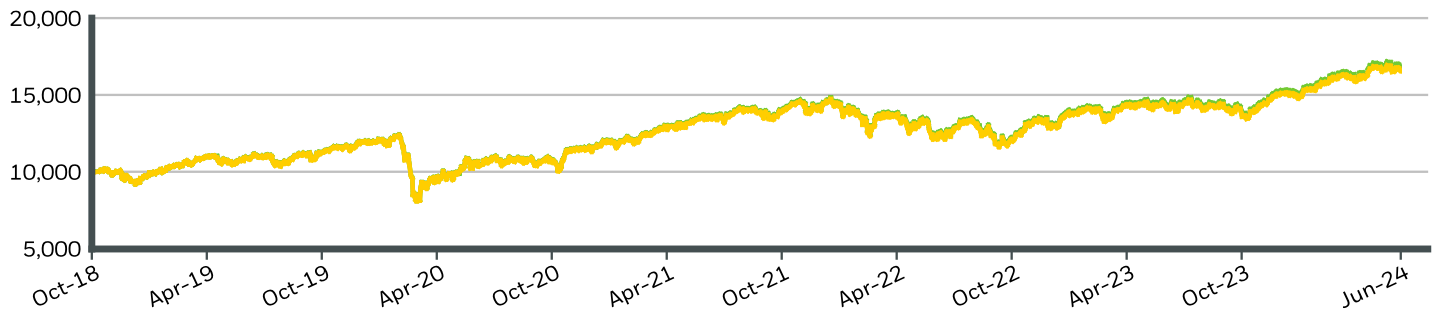

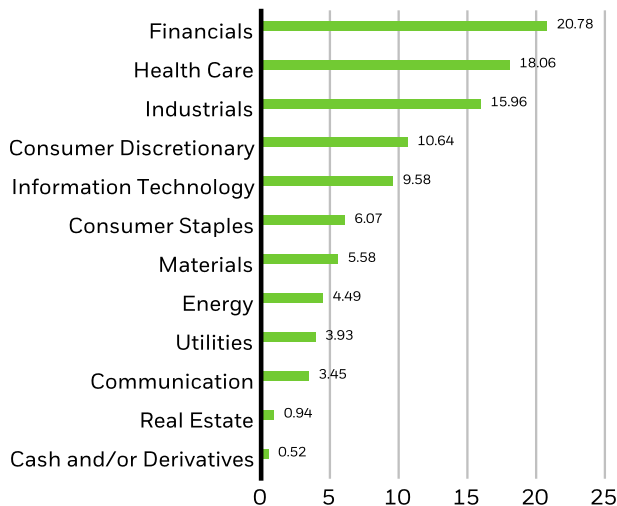

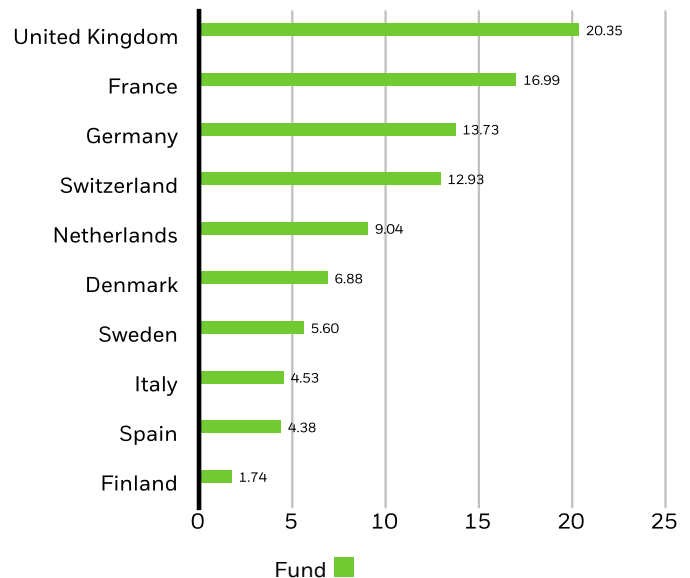
### SECTOR BREAKDOWN (%)
