#### FUND OVERVIEW

- The Fund invests globally at least 70% of its total assets in equity securities (e.g. shares) of companies domiciled in, or the main business of which is in, developed markets.

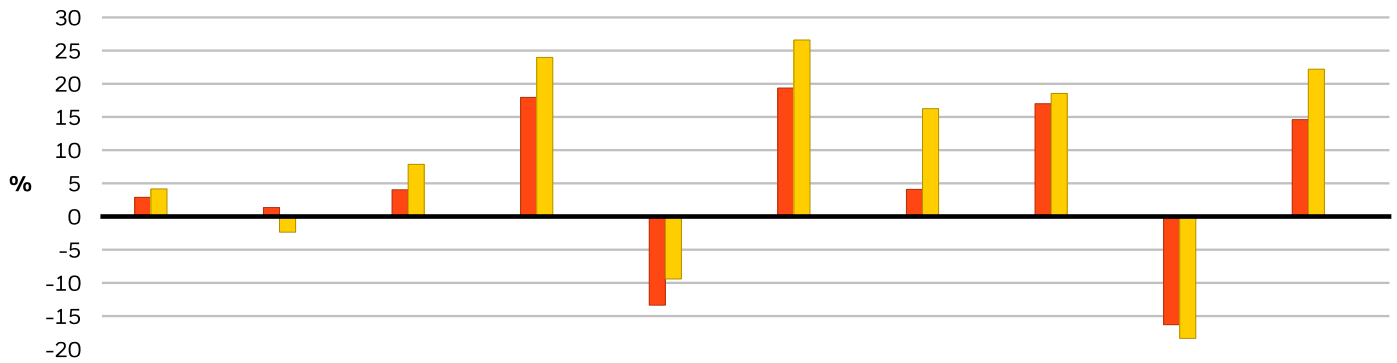

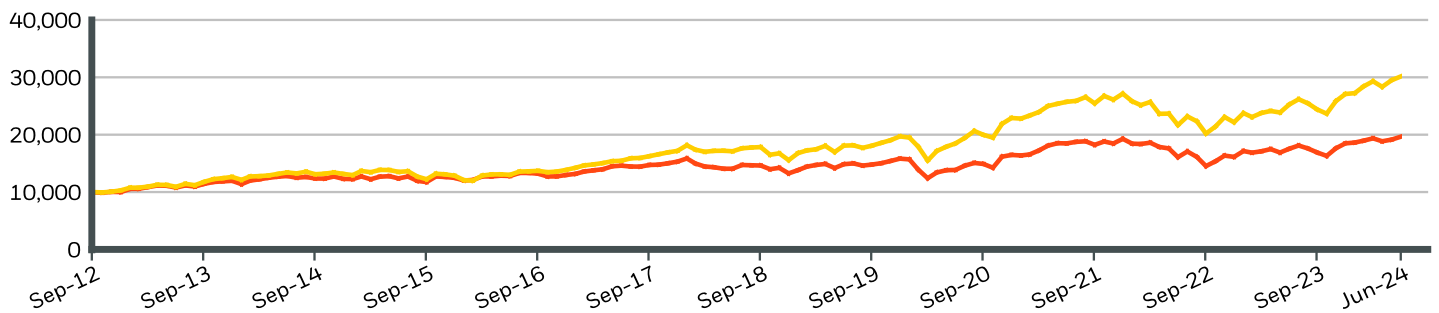

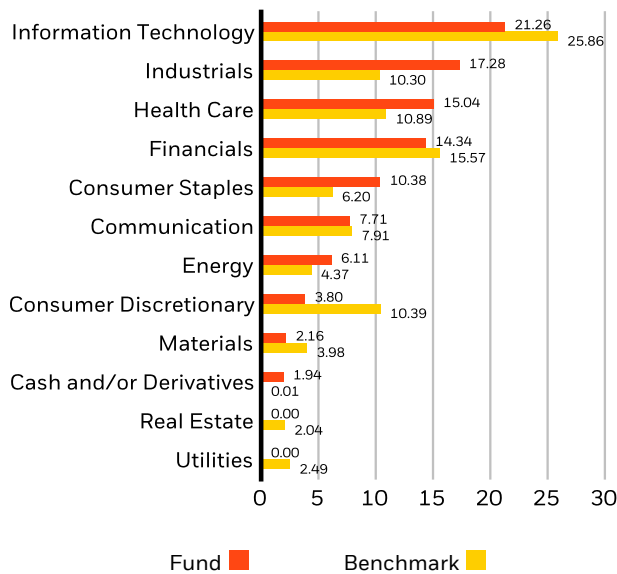

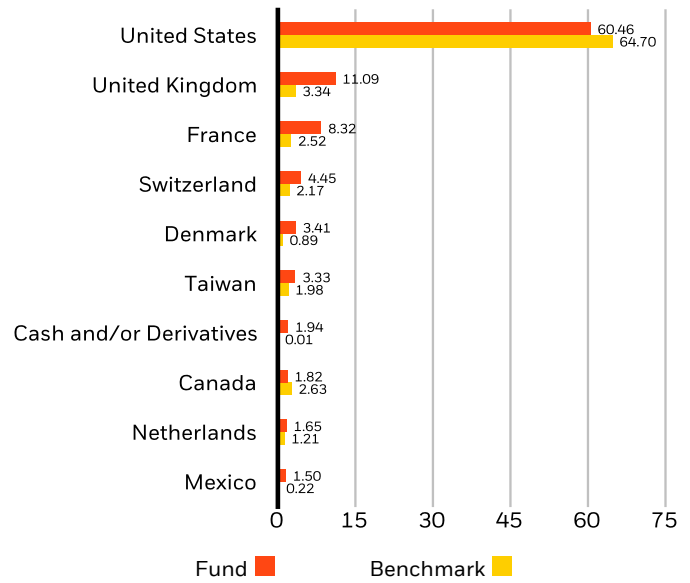

#### SECTOR BREAKDOWN (%)



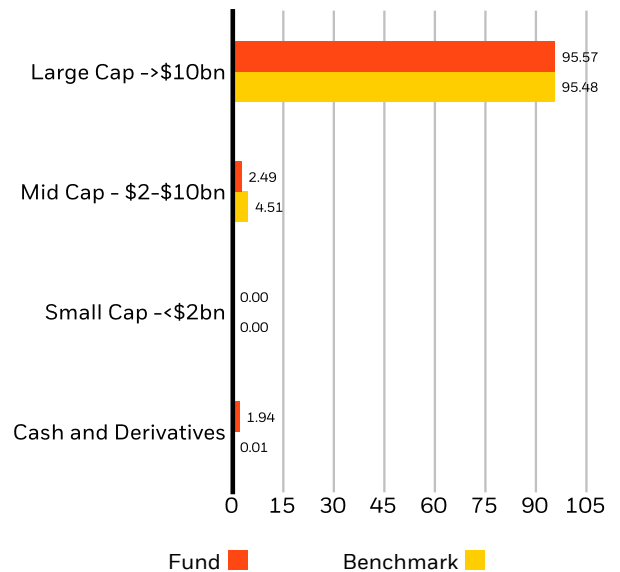
