Objective


To generate growth over the long term (5 years or more) by investing in UK equities (company shares).

Performance Target: To exceed the return of the FTSE All-Share Index by 0.75% per annum over rolling three year periods (before charges). There is no certainty or promise that the Performance Target will be achieved. The FTSE All-Share Index (the "Index") is a representative index of the UK stock market.

Portfolio Securities

- The fund will invest at least 70% in UK equities that make up the Index.
- The fund may also invest in other funds (including those managed by abrdn), cash or assets that can be turned into cash quickly, and to a small extent equities which do not make up the Index.



- The management team use their discretion (active management) to identify the investments they believe are most appropriate for the fund's objective.
- The management team uses numerical techniques to select investments, seeking to improve the level of return that can be achieved for a level of risk similar to that of the index.
- Due to the nature of the management process, the fund's performance profile is not expected to deviate significantly from that of the Index over the long term.
