

**Investment Objective** Achieving long term capital growth in real terms and steadily increasing income. Our aim is to achieve a higher rate of total return than the FTSE Actuaries All-Share Index Total Return through investing in a diversified portfolio of stocks.

## Fund Managers' Comments

In April the Trust's net asset value (cum income, with debt at fair value) rose 1.4%, underperforming the FTSE All-Share benchmark which rose 2.5%. It was a month in which some large UK companies (which form a substantial part of the benchmark, such as HSBC and Shell), performed well. While we hold the likes of HSBC and Shell in this portfolio, they are held at lower weights than within the benchmark and this detracted from our relative performance.

In a continuation of what we have seen for much of this year, takeover activity continued within the UK equity market. In April there was takeover interest for Hipgnosis Songs Fund, International Distribution Services (previously Royal Mail) and Anglo American (all of which are held within this portfolio). This ongoing takeover interest serves, in our view, to highlight the valuation opportunity in UK equities.

During the month a new position was purchased in autos supplier Dowlais, which is a relatively new listing on the UK market having spun out of Melrose. The company has substantial market share amongst the worlds biggest auto manufacturers and has been right sizing its manufacturing footprint in recent years as well as reducing central costs such as procurement. These cost reductions mean the company is guiding to margin improvement in the coming years which is not, in our view, being reflected in the current valuation. Elsewhere the position in Hipgnosis Songs Fund was sold following takeover interest and the position in Rolls-Royce was reduced following good performance.

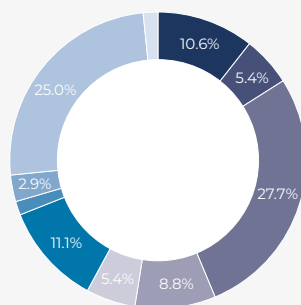

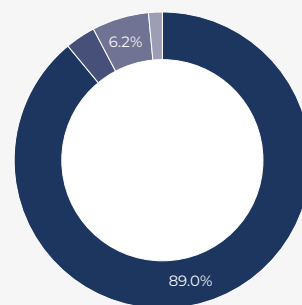
