CHANGES TO THE COMPANY AND THE FUND

On 1 October 2023 the Authorised Corporate Director T. Bailey Fund Services Limited ('TBFS') changed their name to Waystone Fund Services (UK) Limited ('WFSL'). The Company changed its name from TB Evenlode Investment Funds ICVC to WS Evenlode Investment Funds ICVC.

Since the previous year end, WFSL has also undergone a review of the engagement of the Company's Auditors. Following this review, WFSL took the decision to end the audit engagement with Deloitte LLP and to appoint Cooper Parry Group Limited as the Auditors of the Company. WFSL took this decision as it believes that this is in best interests of the Company's shareholders.

On 9 March 2024 the following changes were made:

- The Authorised Corporate Director of the Company changed from WFSL to Investment Fund Services Limited ('IFSL').
- The Company changed its name from WS Evenlode Investment Funds ICVC to IFSL Evenlode Investment Funds ICVC.
- The Custodian of the Company changed from The Northern Trust Company to CACEIS Bank, UK branch.

THE AUTHORISED CORPORATE DIRECTOR AND INVESTMENT MANAGER

The Authorised Corporate Director (the 'ACD') is Investment Fund Services Limited ('IFSL'). Evenlode Investment Management Limited is the Investment Manager (the 'Investment Manager') of IFSL Evenlode Investment Funds ICVC (the 'Company').

Evenlode Investment Management Limited and Investment Fund Services Limited are authorised and regulated by the Financial Conduct Authority. Further information about Evenlode Investment Management Limited can be found at the website: www.evenlodeinvestment.com

YOUR INVESTMENTS

You can buy or sell shares in the sub-funds of the Company through your Financial Advisor. Application forms can be requested in writing from the ACD or by calling the Registrar on the dealing line. They can also be downloaded from the website: www.waystone.com.

The sub-funds of the Company are eligible for ISA investments/transfers and the shares are available as part of a regular savers scheme.

AUTHORISED STATUS

IFSL Evenlode Investment Funds ICVC (the 'Company') is an investment company with variable capital incorporated in England and Wales under registered number IC001091 and authorised by the Financial Conduct Authority with effect from 27 June 2017 with PRN 777896. The Company has an unlimited duration.

STRUCTURE OF THE COMPANY

The Company is a UK UCITS.

The Company is structured as an umbrella company, in that different sub-funds may be established from time to time by the ACD with the agreement of the Depositary and the approval of the FCA. On the introduction of any new sub-fund, or share class, a revised prospectus will be prepared and issued setting out the relevant details of each sub-fund or share class.

The Company is compliant with the Protected Cell Regime for OEICs. Under the Protected Cell Regime, each sub-fund represents a segregated portfolio of assets and accordingly, the assets of a sub-fund belong exclusively to that sub-fund and shall not be used or made available to discharge (directly or indirectly) the liabilities of, or claims against, any other person or body, including any other sub-fund and shall not be available for any such purpose.

As at the balance sheet date, there were three sub-funds: IFSL Evenlode Income, IFSL Evenlode Global Income and IFSL Evenlode Global Equity*.

The base currency of the Company is Pound Sterling.

The assets of the sub-funds have been invested in accordance with the investment objectives and investment policy of the sub-funds. Investment of the assets must comply with the Financial Conduct Authority's Collective Investment Schemes Sourcebook.

Subject to the above, the liabilities, expenses, costs, and charges of the Company will be allocated between classes in accordance with the terms of shares of those classes.

Shareholders are not liable for the debts of the Company. Shareholders are not liable to make any further payment to the Company after they have paid the price on purchase of the shares.

The ACD is the sole director of the Company.

*On 1 October 2023 TB Evenlode Income changed its name to WS Evenlode Income, TB Evenlode Global Income changed its name to WS Evenlode Global Income and TB Evenlode Global Equity changed its name to WS Evenlode Global Equity. Following this change on 9 March 2024 WS Evenlode Income changed its name to IFSL Evenlode Income, WS Evenlode Global Income changed its name to IFSL Evenlode Global Income and WS Evenlode Global Equity changed its name to IFSL Evenlode Global Equity.

CROSS HOLDINGS BETWEEN SUB-FUNDS

As at the year-end there were no cross holdings between the three sub-funds.

REMUNERATION POLICY OF THE AUTHORISED CORPORATE DIRECTOR

Introduction and Scope

WFSL has policies and practices for those staff whose professional activities have a material impact on the risk profile of the combined activities. WFSL is a UCITS firm and is therefore subject to the UCITS Remuneration Code.

The Remuneration Policy:

- Is consistent with and promotes sound and effective risk management;
- Does not encourage risk taking that exceeds the level of tolerated risk of the firm;
- Encourages behaviour that delivers results which are aligned to the interests of WFSL's clients and the UCITS funds it manages;
- Aligns the interests of senior management and staff with material impact ('Code Staff') with the long-term interests of WFSL's clients and the UCITS funds it manages;
- Recognises that remuneration should be competitive and reflect both financial and personal performance. Accordingly, Remuneration for Code Staff is made up of fixed pay (salary and benefits, including pension) and variable (performance-related) pay; and
- Recognises that fixed and variable components should be appropriately balanced and that the variable component should be flexible enough so that in some circumstances no variable component may be paid at all. Variable pay is made up of short-term awards typically based on short-term financial and strategic measures for the area of the business in which the member of Code Staff works.

In accordance with BIPRU 11.5.18R the following disclosures are made:

Decision making process for determining remuneration policy, link between pay and performance

There is no remuneration committee. Remuneration is set within the context of a 5-year plan which ensures any threats to capital adequacy, liquidity and solvency caused by excessive remuneration would be identified. The bonus and commission arrangements including the staff bonus pool are set annually as part of the annual operating plan and any changes to the pool require approval by the WFSL Board.

To assist with the above process, a benchmarking exercise was conducted in 2019 which incorporated information from external consultants in connection with remuneration.

Policy on link between pay and performance

The staff bonus scheme is operated to allow for meaningful rewards to be paid to staff whose performance during the year merits recognition but within the context of an annual operating plan. The Board bears in mind the projected performance of the company when making any adjustments to the scheme. This is agreed within the setting of the annual operating plan and reviewed once full year results are available.

The final bonus total is signed off by the WFSL board. The bonus payments are non-contractual and can be amended or withdrawn at any time.

Payment of scheme bonus to individuals is linked to their performance against agreed objectives from staff appraisals. All bonuses are monetary and paid through the payroll.

REMUNERATION POLICY OF THE AUTHORISED CORPORATE DIRECTOR (CONTINUED)

Staff are eligible to be a part of the scheme once they have completed a full years' service prior to the start of the relevant appraisal year. The same process applies to all grades of staff including executive directors.

There are no commission based payments made to staff.

No other pay reward schemes exist within the business.

STATEMENT OF THE AUTHORISED CORPORATE DIRECTOR'S RESPONSIBILITIES

The Authorised Corporate Director (the "ACD") of IFSL Evenlode Investment Funds ICVC (the "Company") is responsible for preparing the Annual Report and the Financial Statements in accordance with the Open-Ended Investment Companies Regulations 2001 ("the OEIC Regulations"), the Financial Conduct Authority's Collective Investment Schemes' Sourcebook ("COLL") and the Company's Instrument of Incorporation.

The OEIC Regulations and COLL require the ACD to prepare financial statements for each accounting period which:

- are in accordance with United Kingdom Generally Accepted Accounting Practice ("United Kingdom Accounting Standards and applicable law"), including FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Statement of Recommended Practice: "Financial Statements of UK Authorised Funds" issued by the Investment Association ("IA SORP") in May 2014 and amended in June 2017; and
- give a true and fair view of the financial position of the Company and each of its sub-funds as at the end of that period and the net revenue and the net capital gains or losses on the property of the Company and each of its sub-funds for that period.

In preparing the financial statements, the ACD is required to:

- select suitable accounting policies and then apply them consistently;
- make judgments and estimates that are reasonable and prudent;
- state whether applicable United Kingdom Accounting Standards and the IA SORP have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Company will continue in operation.

The ACD is responsible for keeping adequate accounting records that disclose with reasonable accuracy at any time the financial position of the Company and enable it to ensure that the financial statements comply with the applicable IA SORP and United Kingdom Accounting Standards and applicable law. The ACD is also responsible for the system of internal controls, for safeguarding the assets of the Company and for taking reasonable steps for the prevention and detection of fraud and other irregularities.

DIRECTORS' STATEMENT

In accordance with COLL 4.5.8BR, the Report and the Financial Statements were approved by the board of directors of the ACD of the Company and authorised for issue on 17 June 2024.

The Directors are of the opinion that it is appropriate to continue to adopt the going concern basis in the preparation of the financial statements as the assets of the Company and its sub-funds consist predominantly of readily realisable securities and accordingly the Company has adequate resources to continue in operational existence for at least the next twelve months from the approval of these financial statements.

The Depositary also has a duty to take reasonable care to ensure that the Company is managed in accordance with the Regulations and the Scheme documents in relation to the investment and borrowing powers applicable to the Company.

Report on the audit of the financial statements

Opinion

In our opinion the financial statements of IFSL Evenlode Investment Funds ICVC (the 'company'):

- give a true and fair view of the financial position of the sub-funds as at 29 February 2024 and of the net revenues and the net capital gains on the property of the sub-funds for the year ended 29 February 2024; and
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice, including Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland", the Statement of Recommended Practice "Financial Statements of UK Authorised Funds", the rules in the Collective Investment Schemes Sourcebook and the Instrument of Incorporation.

We have audited the financial statements which comprise for each sub-fund:

- the statement of total return;
- the statement of change in net assets attributable to shareholders;
- the balance sheet;
- the related notes 1 to 15; and
- the distribution tables.

Our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the course of the audit, or otherwise appears to be materially misstated. If we identify such material inconsistencies or apparent material misstatements, we are required to determine whether this gives rise to a material misstatement in the financial statements themselves. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

We have nothing to report in this regard.

Responsibilities of Depositary and ACD

As explained more fully in the statement of Depositary's responsibilities and the statement ACD's responsibilities, the depositary is responsible for the safeguarding the property of the company and the ACD is responsible for the preparation of the financial statements and for being satisfied that they give a true and fair view, and for such internal control as the ACD determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the ACD is responsible for assessing the company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the ACD either intends to liquidate the company or to cease operations, or has no realistic alternative but to do so.

Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

We are not responsible for preventing irregularities. Our approach to detect irregularity included, but was not limited to, the following:

- obtaining an understanding of the legal and regulatory framework applicable to the company to assess compliance with provisions of relevant laws and regulations. This included ensuring compliance with the Collective Investment Schemes Sourcebook.
- obtaining an understanding of the company's policies and procedures and how the company has complied with these, through discussions and process walkthroughs.
- obtaining an understanding of the company's risk assessment process, including the risk of fraud, designing our audit procedures to respond to our risk assessment. This included performing analytical procedures to identify any unusual or unexpected relationships that may indicate risks of material misstatement due to fraud.
- enquiring of management concerning actual and potential litigation and claims and understanding whether there have been instances of non-compliance with laws and regulations; and
- reviewing minutes of those charged with governance and reviewing correspondence with the FCA.

IFSL EVENLODE INCOME, AUTHORISED STATUS

IFSL Evenlode Income ('the Fund') is a sub-fund of IFSL Evenlode Investment Funds ICVC with investment powers equivalent to those of a UK UCITS as defined in the Glossary to the Financial Conduct Authority ('FCA') Handbook.

INVESTMENT OBJECTIVE AND POLICY

The investment objective of IFSL Evenlode Income (the 'Fund') is to provide income and capital growth over rolling periods of 5 years, with an emphasis on income.

At least 80% of the Fund will be invested in the equity securities of companies listed in the United Kingdom.

The Fund may also invest in equity securities of companies listed globally, fixed income securities, cash (or near cash) and up to 10% in collective investment schemes (which may include schemes managed or operated by the ACD or its associates).

The Fund may invest in derivatives to reduce risk or cost or to generate additional capital or income at proportionate risk (known as "Efficient Portfolio Management").

The Fund is actively managed and the Investment Manager focuses on companies which offer a combination of high and growing cash-flows (to deliver both capital growth and dividend growth for the Fund) and low business risk. The Investment Manager will perform analysis to identify shares in companies that offer this combination. As part of this analysis, the Investment Manager will consider a company's free cash flow generation. This is a financial measure of how much surplus cash a company is able to generate after funding its operating costs, working capital, capital expenditures, interest and tax. A high level of free cash flow indicates to the Investment Manager that a company has sufficient cash flow to satisfy its obligations, including the ability to provide a sustainable dividend stream.

ONGOING CHARGES FIGURE

The Ongoing Charges Figure ('OCF') provides investors with a clearer picture of the total annual costs in running a Collective Investment Scheme. The OCF consists principally of the Annual Management Charge, but also includes the costs for other services paid in respect of Depositary, custody, FCA and audit fees. The Fund has a fixed periodic charge. The OCFs, as calculated in accordance with ESMA guidelines, are disclosed as 'Operating charges (p.a.)' in the Comparative Tables on pages 19 to 24.

SYNTHETIC RISK AND REWARD INDICATOR

The Synthetic Risk and Reward Indicator demonstrates in a standard format where the Fund ranks in terms of its potential risk and reward. It is based on historical performance data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The indicator uses a scale of one to seven. The higher the rank the greater the potential reward but the greater the risk of losing money. The lowest category does not mean a fund is a risk free investment.

The FTSE All Share Index is a Comparator Benchmark of the Fund.

Shareholders may also wish to compare the Fund's performance against other funds within the Investment Association's (IA) UK All Companies sector as that will give investors an indication of how the Fund is performing compared with others investing in a similar but not identical investment universe. As the sector aligns with the Fund's asset allocation, it is considered that this is an appropriate comparator.

The IA UK All Companies sector is a Comparator Benchmark of the Fund.

Market Background

The twelve-month period under review began on 1 March 2023. Economic and geopolitical risks were never far from the headlines over the past year. The FTSE All-Share index was down for much of the period and recovered to post a return of 0.6% for the year, whilst most global stock markets ended up posting positive returns. Interest rates continued to march higher, as central banks attempted to rein-in the post-pandemic inflationary spike, and this had a cooling effect on both inflation and global economic activity. Towards the end of 2023 central banks began hinting that we may have arrived at the top of the interest rate cycle which led to a rally* in the global stock market from the end of October

Investment Review

Performance

The total return (i.e. combined return from dividends and capital performance) for IFSL Evenlode Income was 6.1% (B Accumulation shares) during the twelve-month period to 29 February 2024 compared to 0.6% for the FTSE All-Share Index and 0.1% for the IA UK All Companies sector. (Source – FE Analytics, GBP terms).

The Fund continues to outperform both comparator benchmarks over rolling 5-year periods (the minimum recommended holding period for the Fund) and since launch in October 2009, the Fund has risen +313.4% compared to +159.4% for the FTSE All-Share and +148.2% for the IA UK All Companies sector.

From a dividend perspective, the Fund's full year dividend increased +8.9%. The Fund's income stream is well covered by cash generation and, combined with growth opportunities for underlying holdings, this bodes well for real dividend growth prospects over coming years.

Performance Drivers

The Fund's outperformance was driven mainly by overweight positions (where the fund had a larger weighting compared to the FTSE All-Share Index comparator benchmark) in technology and data analytics businesses which performed well, including Sage, Microsoft, RELX, Wolters Kluwer and Experian. This more than offset underperformance in consumer staples, in which the Fund also had a larger weighting than the benchmark. In terms of company performance, the majority of portfolio companies have updated the market since the start of 2024, and while the economic backdrop has not been easy, the aggregate portfolio is making reassuring progress, with organic revenue growth (which excludes growth arising from mergers and acquisitions) for 2023 averaging +6% (*Source: Evenlode, Visible Alpha). The outlook for profitability is improving as input cost inflation (changes in prices of materials, fuel and other costs which companies face) falls back to more normal levels, and global wage inflation is easing back. Growth in free cash flow** is also healthy, helped by the normalisation of supply chains and stock levels.

For the review period, the most positive contributors to return were RELX, Sage, Microsoft and Experian. RELX, a leading provider of information and data analytics to corporates and academic institutions, delivered strong growth in 2023 driven by the continued shift in business towards higher growth digital analytics and decision tools. Sage continues to benefit from increasing adoption of cloud-based financial software by small and medium sized businesses. Microsoft's strong position in cloud software and infrastructure drove double digit growth in revenue and profit over the past year. Experian, a leading credit referencing agency, delivered solid growth in 2023 despite tightening credit conditions in the US, benefiting from the broadening of its data and software offering across credit risk, marketing, decisioning and fraud prevention.

The most negative contributors to the Fund's return were Diageo, Burberry, Reckitt Benckiser and Victrex. At Diageo, the global leader in spirits, sales weakened over the past year as consumer demand slowed and retail and distribution customers reduced stock levels. Medium term growth prospects remain attractive, driven by the move to premium brands in developed markets and increasing penetration of premium spirits in emerging markets. Burberry saw a slowdown in sales during 2023, following a period of strong growth as economies reopened from pandemic-related lockdowns. We view Burberry as well positioned for the medium and long term. It is a strong heritage brand and has built direct distribution in key markets across Europe, the US and Asia, helping to strengthen its customer relationships and pricing power. Its net cash balance sheet is particularly helpful during this period of higher interest rates and weaker demand, allowing management to continue investing appropriately for future growth. Reckitt is a market leader in the health and hygiene consumer goods categories and reported solid sales growth in 2023 despite a slight decline in the last quarter as its main competitor in the US infant nutrition market recovered from a product recall. Encouragingly, management significantly increased brand investments in 2023 and are focused on returning Reckitt to consistent mid-single-digit organic sales growth, following a period of volatility*** caused by Covid and competitor supply chain issues. Victrex is the market leader in PEEK, a high performance polymer typically used to replace metal in demanding applications across a range of industries including aeroplanes, cars, medical devices and energy infrastructure. Sales decreased over the past year as the global economy slowed and industrial customers reduced stock levels. Looking further out, growth prospects are strong as PEEK's

superior performance and sustainability characteristics drives adoption in new applications, with a strong focus commercialising PEEK in the medical sector in areas such as knee implants and trauma plates.

Portfolio Changes

In terms of portfolio changes, we were less active than in the previous financial year (during which we added seven holdings and exited six). We continued, though, to evolve the portfolio as we look to optimise the combination of quality and valuation appeal.

We added one new position from July – Spirax Sarco. Spirax is the global leader in steam and electric systems essential for the transfer of heat and energy into industrial processes. Deep knowledge of customers' industrial systems drives longer-term relationships and a solid base of recurring revenue from maintenance and modernisation projects, with the business generating strong operating margins of 20%+ and organic growth averaging around 2x the rate of global industrial production historically. Growth prospects are strong as it helps customers meet efficiency and decarbonisation targets.

We also topped up a wide range of existing holdings including Experian, Diageo, Savills, Halma, Integrafina, Hays, Howden, Roche, Burberry, Victrex, SGS and Smith & Nephew.

To make room for these additions, we exited Cisco, Moneysupermarket and Astrazeneca. We also reduced a number of other holdings for valuation reasons – most notably Procter & Gamble and PepsiCo. In the last few months of the financial year, we also trimmed back the Fund's holdings in Sage, Microsoft, Wolters Kluwer and RELX, as their relative valuation and dividend appeal reduced somewhat due to strong share price appreciation.

Outlook

Looking ahead, the outlook is not without complications. The geopolitical backdrop is challenging as uncertainty persists over the Russia/Ukraine conflict, tensions in the Middle East, and China's relationship with Western liberal democracies. 2024 is also the biggest election year in history, with more than 60 countries (representing half the world's population) holding elections – including the UK and the US. On the economic front, one can credibly take either a half-empty or half-full view. For the pessimists, the effects of higher interest rates continue to work their way through the system. For the optimists, inflation is cooling rapidly and interest rates could fall quite significantly in 2024.

With these uncertainties in mind, we think that Evenlode Income's underlying holdings are in good shape to cope with the wide range of operational conditions that may prevail, as they have done over the last few volatile years.

With times tough and interest rates back at more normal levels, sensibly run market-leading companies with self-funding business models and strong balance sheets are well placed to strengthen their competitive position. We suspect that this theme has further to run – and it applies just as much to more economically sensitive holdings as it does to the repeat-purchase bedrock of the Fund. Valuations are also attractive, with most high-quality UK-listed cash compounders trading on modest valuations. The Fund's free cash flow yield**** stands at a healthy 5.1%. This resilient free cash flow** stream provides a nice safety buffer for the Fund's 2.8% dividend yield****, and we think prospects for dividend growth are good thanks to the cash compounding potential of the aggregate portfolio over coming years.

1. Accounting policies**(a) Basis of accounting**

The financial statements have been prepared under the historical cost basis, as modified by the revaluation of investments, and in accordance with Financial Reporting Standard 102 (FRS 102) and in accordance with the Statement of Recommended Practice (SORP) for Financial Statements of UK Authorised Funds issued by the Investment Association in May 2014 and amended in June 2017.

The Directors are of the opinion that it is appropriate to continue to adopt the going concern basis in the preparation of the financial statements as the assets of the Company and its sub-funds consist predominantly of readily realisable securities and accordingly the Company has adequate resources to continue in operational existence for at least the next twelve months from the approval of the financial statements.

(b) Functional currency

The functional currency used in the financial statements is Pound Sterling because it is the currency of the primary economic environment in which the Company operates.

(c) Recognition of revenue

Dividends on holdings, net of any irrecoverable tax credits, are recognised when the underlying equity is quoted ex-dividend. Bank interest is accounted for on an accruals basis.

All revenue is recognised on the condition that the flow of economic benefits is probable and the amount can be measured reliably.

(d) Treatment of stock dividends

Stock dividends are credited to the capital account when the stock is quoted ex-dividend. The cash equivalent is then transferred to the revenue account and forms part of the distributable revenue.

The allocation of special dividends is considered on a case-by-case basis in determining whether the dividend is to be treated as revenue or capital.

(e) Treatment of expenses

All expenses, net of any associated tax effect, are allocated to the capital account with the exception of bank interest which is allocated to the revenue account on an accrual basis.

(f) Allocation of revenue and expense to multiple share classes

Any assets or liabilities not attributable to a particular share class are allocated by the ACD in a manner which is considered fair to shareholders in general, usually pro-rata based on the net asset values of the relevant share classes.

IFSL EVENLODE INCOME, NOTES TO THE FINANCIAL STATEMENTS (CONTINUED)

1. Accounting policies (continued)**(g) Taxation/deferred taxation**

Corporation tax is provided for on taxable revenue, less deductible expenses, at a rate of 20%. This is the rate that has been enacted or substantially enacted by the balance sheet date.

Deferred tax is provided for in respect of all items that have been included in these financial statements, or those of a previous period, that will be included in future periods for taxation purposes, other than those timing differences regarded as permanent. Any liability to deferred tax is provided for at the rate of tax expected to apply.

Income tax on interest distributions is classed as 'income tax recoverable' and is recovered on a yearly basis on submission of the Fund's annual tax return.

(h) Distribution Policy

Revenue produced by the Fund's investments is accrued quarterly. At the end of each period, the revenue, plus an adjustment for expenses allocated to capital, is distributed/accumulated at the discretion of the Investment Manager, as per the prospectus.

If a distribution made in relation to any income shares remains unclaimed for a period of six years after it has become due, it will be forfeited and will become the property of the Fund.

(i) Exchange rates

Assets and liabilities in overseas currencies at the year-end are translated into Sterling at the latest available rates of exchange on the balance sheet date. Transactions in overseas currencies occurring during the year are recorded at the rate of exchange on the date of the transaction.

(j) Financial instruments

Financial assets and financial liabilities are recognised in the Fund's balance sheet when the Fund becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially recognised at transaction price (including transaction costs) and subsequently measured at amortised cost, except for the Fund's investments classified as financial assets at fair value through profit or loss, which are initially recognised at fair value (excluding transaction costs).

The investments are measured at bid prices, and quoted prices for single priced funds, on the balance sheet date, with any gains or losses arising on measurement recognised in the statement of total return. If bid prices and quoted price for single priced funds are not available, the latest available prices are used. If separate offer and bid prices are quoted for shares or units, then the bid price is used. If no price or recent available price exists, the investments are valued at a price which, in the opinion of the ACD, reflects the fair value of the asset. This may involve the use of an appropriate valuation technique/methodology.

(k) Significant judgements and key sources of estimation uncertainty

There have been no significant judgements or sources of estimated uncertainty in the period.

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. This includes counterparty and issuer risk. Cash is held with reputable credit institutions and credit risk is assessed on a regular basis.

Certain transactions in securities that the Fund enters into expose it to the risk that the counterparty will not deliver the investment for a purchase, or cash for a sale after the Fund has fulfilled its obligations. The Fund only buys and sells investments through brokers which have been approved by the ACD as an acceptable counterparty and these are reviewed on an ongoing basis.

(e) Market price risk

The value of shares/units in the underlying investments is not fixed and may go down as well as up. This may be the result of a specific factor affecting the value of an individual share/unit held within an underlying investment or be caused by general market factors (such as government policy or the health of the underlying economy) which can affect the entire portfolio.

The Investment Manager seeks to minimise these risks by holding diversified portfolios of collective investment schemes and transferable securities in line with the investment objectives. In addition, the management of the Fund complies with the Financial Conduct Authority's Collective Investment Schemes sourcebook, which includes rules prohibiting a holding greater than 20% of the assets of the Fund in any one underlying investment.

If the value of shares/units in the underlying investments were to increase or decrease by 10% the change in the net asset value of the Fund would be £328,695,261 (28 February 2023: £350,812,394). This calculation assumes all other variables remain constant.

IFSL EVENLODE GLOBAL INCOME, AUTHORISED STATUS

IFSL Evenlode Global Income (‘the Fund’) is a sub-fund of IFSL Evenlode Investment Funds ICVC with investment powers equivalent to those of a UK UCITS as defined in the Glossary to the Financial Conduct Authority (‘FCA’) Handbook.

INVESTMENT OBJECTIVE AND POLICY

The investment objective of IFSL Evenlode Global Income (the ‘Fund’) is to provide income and capital growth over rolling periods of 5 years with an emphasis on income.

At least 80% of the Fund will be invested in equity securities of companies listed on international exchanges.

The Fund may also invest in cash (or near cash securities) and, up to 10% in collective investment schemes (which may include schemes managed or operated by the ACD or its associates).

The Fund may invest in derivatives to reduce risk or cost or to generate additional capital or income at proportionate risk (known as “Efficient Portfolio Management”).

The Fund is actively managed, and the Investment Manager aims to invest in a focused portfolio of equity securities of companies which offer a combination of high and growing cash-flows (to deliver both capital growth and dividend growth for the Fund) and low business risk. The Investment Manager will perform analysis to identify shares in companies that offer this combination. As part of this analysis, the Investment Manager will consider a company’s free cash flow generation. This is a financial measure of how much surplus cash a company is able to generate after funding its operating costs, working capital, capital expenditures, interest and tax. A high level of free cash flow indicates to the Investment Manager that a company has sufficient cash flow to satisfy its obligations, including the ability to provide a sustainable dividend stream.

ONGOING CHARGES FIGURE

The Ongoing Charges Figure (‘OCF’) provides investors with a clearer picture of the total annual costs in running a Collective Investment Scheme. The OCF consists principally of the Annual Management Charge, but also includes the costs for other services paid in respect of Depositary, custody, FCA and audit fees. The Fund has a fixed periodic charge. The OCFs, as calculated in accordance with ESMA guidelines, are disclosed as ‘Operating charges (p.a.)’ in the Comparative Tables on pages 51 to 65.

SYNTHETIC RISK AND REWARD INDICATOR

The Synthetic Risk and Reward Indicator demonstrates in a standard format where the Fund ranks in terms of its potential risk and reward. It is based on historical performance data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The indicator uses a scale of one to seven. The higher the rank the greater the potential reward but the greater the risk of losing money. The lowest category does not mean a fund is a risk free investment.

The Fund is in risk category five because its investments have experienced moderate to high volatility in the past.

IFSL EVENLODE GLOBAL INCOME, RISK PROFILE

The Fund will be exposed to financial markets and market conditions can change rapidly. Prices can move irrationally and be affected unpredictably by diverse factors, including political and economic events.

FUND BENCHMARKS

The stocks comprising the Index are aligned with the Fund's global focus, and on that basis the Index is considered an appropriate performance comparator for the Fund. Please note the Fund is not constrained by or managed to the Index.

The MSCI World Index (GBP) is a Comparator Benchmark of the Fund.

Shareholders may also wish to compare the Fund's performance against other funds within the Investment Association's (IA) Global Equity Income sector as that will give investors an indication of how the Fund is performing compared with other funds that invest in global equities and have an income focus. As the sector aligns with the Fund's asset allocation and income delivery objectives, it is considered that this is an appropriate comparator.

The IA Global Equity Income sector is a Comparator Benchmark of the Fund.

Market Background

The global equity market was very strong in the year to end-February 2024, with the benchmark MSCI World index returning 19.6% in sterling. The Fund also produced a positive return, but a more modest 8.2% for the B Acc GBP units. (Source – FE Analytics, GBP terms). The broader market has been driven by large technology companies in the Global Industry Classification Standard (GICS) Information Technology and Communications Services sectors, but the rally* was seen across most sectors. Positive sentiment has been fired up by the promises of artificial intelligence and the rapidly rising revenues seen at companies like Artificial Intelligence (AI) chipmaker NVIDIA, a strong United States (US) economy, and falling inflation raising the prospects for central bank interest rate cuts. With 71% of the benchmark being made up of companies listed in the US³, the performance of the global stock market is fundamentally linked to the country and particularly the large technology companies that dominate it. The top ten constituents of the index make up 22% of its weight, and only two companies, Lilly and Tesla, are not information technology or communications businesses.

Looking at underlying company performance, sales (revenue) growth for the benchmark slowed significantly in 2023 over 2022 to around 1% in US dollars, as did profitability growth, and dividends paid grew at 5% as a post-pandemic rebuilding of payouts continued. In this context the median** organic revenue growth (which excludes growth arising from mergers and acquisitions) reported by portfolio companies of 6% is an encouraging signal of consistent fundamental performance within the Fund, as is the year-on-year dividend growth from the Fund of 7.7% in sterling terms (B Inc GBP shares).

Investment Review

Performance

By sector the Information Technology exposure of the Fund contributed the most with a return of 31% within the portfolio. This sector was also the biggest source of relative underperformance compared to the benchmark, a sign of just how strong the sector has been returning 51% in the broader market. Whilst some of this strength is justified by very strong corporate performance, it has left valuations in a less appealing place and we have reduced the Fund's holdings in the sector to reflect the changing valuation risk landscape.

The Industrials sector was the second strongest performer for the portfolio, returning 16% and was the biggest source of relative outperformance. For the Fund the sector name is something of a misnomer, consisting predominantly of Commercial and Professional Services firms like Wolters Kluwer, RELX and Experian. Being providers of software, data and analytics to different industries, these companies have found favour in the market as potential beneficiaries of the application of artificial intelligence tools within their products. As with the Information Technology sector we have reduced exposure incrementally to certain companies where the valuations are less attractive than they once were, although remain acceptable in absolute terms.

The Health Care and Consumer Staples sectors are significant exposures for the Fund and the source of attractive dividend yields*** but underperformed in the year with returns of 0% and -2% respectively. Whilst each company has its own story, a general theme that emerged toward the end of the period was companies seeing revenues normalise from unusually high levels during the pandemic generally witnessing negative share price reactions. In the healthcare sector this included medical testing lab operator Sonic Healthcare and pharmaceutical & testing equipment maker Roche. In consumer goods Reckitt's health business was lapping the after-effects of an unusually strong post-pandemic flu season in 2022 as populations emerged from lockdown. It also saw the temporary benefits of competitor supply issues in its infant nutrition business wearing off. In all such cases for portfolio companies our analysis is that the health of the underlying franchises is unaffected, and any negative price reactions mean that valuations remain attractive, indeed becoming more-so.

Portfolio Changes

We discussed the additions of Shimano, Jack Henry, CTS Eventim and Diageo and the sales of Broadridge, Clorox and Wiley during the first half of the year in the Fund's interim report (please see the report for full details).

In the second half of the year we added positions in US payroll and HR services company Paychex, US tool maker Snap-on, and Swiss logistics broker Kuehne + Nagel to the portfolio. All are trading on attractive valuations in the market, have the profitable and cash generative, market leading characteristics that we seek, and bring diversification to the portfolio.

We sold the Fund's positions in German sportswear company adidas, German industrial and consumer conglomerate Henkel, and US consumer goods company PepsiCo. The latter was disposed of on valuation grounds and as we looked to manage the Fund's overall consumer goods exposure. The disposal of adidas was partly on valuation grounds, but also because the company had moved to a net debt position as a result of very tough operating conditions through and in the immediate aftermath of the pandemic. We would prefer such a company to have a stronger balance sheet, so it remains on our 'subs bench' of companies that may make a return to the investable universe (the list of companies which meet Evenlode's quality criteria for investment) should it reduce its debt burden. Henkel was disposed of for more fundamental reasons. The company's industrial adhesives division is a clear market leader and has many attractive qualities, but its consumer division is relatively small compared to competitors and we think that the capital required to create a globally competitive business may hamper returns in the medium term.

Outlook

Looking at corporate performance going forward, analysts at S&P estimate⁴ that global dividend growth will be under 1% in 2024, with US companies leading increases in payouts followed by Europe, but with the Asia Pacific region holding global payouts back. In this context the announced dividend increases from the portfolio averaging +6% in local currencies indicates solid progress should be made within the Fund. Importantly these increases are backed by free cash flow****, with the forward free cash flow yield***** of the portfolio at 4.9% and an underlying (pre-withholding tax) dividend yield of 2.6%.

The free cash flow yield indicates that the portfolio is attractively valued, an observation backed up by our long-term discounted cash flow modelling. A market environment where capital growth is taking charge, as we are currently experiencing, is one where we would expect the strategy to deliver positive returns but perhaps behind the market, as was experienced during the period. However, with our core aim of delivering dividend growth coming through backed by resilient corporate performance and attractive valuations we believe the Fund is set up well for a range of economic and market conditions to come.

1. Accounting policies**(a) Basis of accounting**

The financial statements have been prepared under the historical cost basis, as modified by the revaluation of investments, and in accordance with Financial Reporting Standard 102 (FRS 102) and in accordance with the Statement of Recommended Practice (SORP) for Financial Statements of UK Authorised Funds issued by the Investment Association in May 2014 and amended in June 2017.

The Directors are of the opinion that it is appropriate to continue to adopt the going concern basis in the preparation of the financial statements as the assets of the Company and its sub-funds consist predominantly of readily realisable securities and accordingly the Company has adequate resources to continue in operational existence for at least the next twelve months from the approval of the financial statements.

(b) Functional currency

The functional currency used in the financial statements is Pound Sterling because it is the currency of the primary economic environment in which the Company operates.

(c) Recognition of revenue

Dividends on holdings, net of any irrecoverable tax credits, are recognised when the underlying equity is quoted ex-dividend. Bank interest and management fee rebates are accounted for on an accruals basis.

All revenue is recognised on the condition that the flow of economic benefits is probable and the amount can be measured reliably.

(d) Treatment of stock dividends

Stock dividends are credited to the capital account when the stock is quoted ex-dividend. The cash equivalent is then transferred to the revenue account and forms part of the distributable revenue.

The allocation of special dividends is considered on a case-by-case basis in determining whether the dividend is to be treated as revenue or capital.

(e) Treatment of expenses

All expenses, net of any associated tax effect, are allocated to the capital account with the exception of bank interest which is allocated to the revenue account on an accrual basis.

(f) Allocation of revenue and expense to multiple share classes

Any assets or liabilities not attributable to a particular share class are allocated by the ACD in a manner which is considered fair to shareholders in general, usually pro-rata based on the net asset values of the relevant share classes.

1. Accounting policies (continued)

(g) Taxation/deferred taxation

Corporation tax is provided for on taxable revenue, less deductible expenses, at a rate of 20%. This is the rate that has been enacted or substantially enacted by the balance sheet date.

Deferred tax is provided for in respect of all items that have been included in these financial statements, or those of a previous period, that will be included in future periods for taxation purposes, other than those timing differences regarded as permanent. Any liability to deferred tax is provided for at the rate of tax expected to apply to the reversal of timing difference.

Income tax on interest distributions is classed as 'income tax recoverable' and is recovered on a yearly basis on submission of the Fund's annual tax return.

(h) Distribution Policy

Revenue produced by the Fund's investments is accrued quarterly. At the end of each period, the revenue, plus an adjustment for expenses allocated to capital, is distributed/accumulated at the discretion of the Investment Manager, as per the prospectus.

If a distribution made in relation to any income shares remains unclaimed for a period of six years after it has become due, it will be forfeited and will become the property of the Fund.

(i) Exchange rates

Assets and liabilities in overseas currencies at the year-end are translated into Sterling at the latest available rates of exchange on the balance sheet date. Transactions in overseas currencies occurring during the year are recorded at the rate of exchange on the date of the transaction.

(j) Financial instruments

Financial assets and financial liabilities are recognised in the Fund's balance sheet when the Fund becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially recognised at transaction price (including transaction costs) and subsequently measured at amortised cost, except for the Fund's investments classified as financial assets at fair value through profit or loss, which are initially recognised at fair value (excluding transaction costs).

The investments are measured at bid prices, and quoted price for single priced funds, on the balance sheet date, with any gains or losses arising on measurement recognised in the statement of total return. If closing prices are not available, the latest available prices are used. If separate offer and bid prices are quoted for shares or units, then the bid price is used. If no price or recent available price exists, the investments are valued at a price which, in the opinion of the ACD, reflects the fair value of the asset. This may involve the use of an appropriate valuation technique/methodology.

(k) Management fee rebates

Management fee rebates are accounted for on an accruals basis and are allocated to the capital or revenue account of the Fund, according to whether the underlying fund charges its fees to capital or revenue.

(l) Significant judgements and key sources of estimation uncertainty

There have been no significant judgements or sources of estimated uncertainty in the period.

All of the Fund's underlying financial assets are considered to be readily realisable. Where investments cannot be realised in time to meet any potential liability, the Fund may borrow up to 10% of its net asset value to ensure settlement. All of the Fund's financial liabilities are payable on demand or in less than one year.

(d) Credit risk

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. This includes counterparty and issuer risk. Cash is held with reputable credit institutions and credit risk is assessed on a regular basis.

Certain transactions in securities that the Fund enters into expose it to the risk that the counterparty will not deliver the investment for a purchase, or cash for a sale after the Fund has fulfilled its obligations. The Fund only buys and sells investments through brokers which have been approved by the ACD as an acceptable counterparty and these are reviewed on an ongoing basis.

(e) Market price risk

The value of shares/units in the underlying investments is not fixed and may go down as well as up. This may be the result of a specific factor affecting the value of an individual share/unit held within an underlying investment or be caused by general market factors (such as government policy or the health of the underlying economy) which can affect the entire portfolio.

The Investment Manager seeks to minimise these risks by holding diversified portfolios of collective investment schemes and transferable securities in line with the investment objectives. In addition, the management of the Fund complies with the Financial Conduct Authority's Collective Investment Schemes sourcebook, which includes rules prohibiting a holding greater than 20% of the assets of the Fund in any one underlying investment.

If the value of shares/units in the underlying investments were to increase or decrease by 10% the change in the net asset value of the Fund would be £181,959,044 (28 February 2023: £169,570,126). This calculation assumes all other variables remain constant.

IFSL EVENLODE GLOBAL EQUITY, AUTHORISED STATUS

IFSL Evenlode Global Equity ('the Fund') is a sub-fund of IFSL Evenlode Investment Funds ICVC with investment powers equivalent to those of a UK UCITS as defined in the Glossary to the Financial Conduct Authority ('FCA') Handbook.

INVESTMENT OBJECTIVE AND POLICY

The investment objective of IFSL Evenlode Global Equity (the 'Fund') is to provide capital growth over rolling periods of 5 years.

At least 80% of the Fund will be invested in equity securities of companies listed on international exchanges.

The Fund may also invest in cash (or near cash securities), and up to 10% in collective investment schemes (which may include schemes managed or operated by the ACD or its associates).

The Fund may invest in derivatives to reduce risk or cost or to generate additional capital or income at proportionate risk (known as "Efficient Portfolio Management").

The Fund is actively managed and the Investment Manager aims to invest in a focused portfolio of equity securities of companies which offer a combination of high and growing cash-flows and low business risk (to deliver long-term capital growth for the Fund). The Investment Manager will perform analysis to identify shares in companies that offer this combination. As part of this analysis, the Investment Manager will consider a company's free cash flow generation and its potential to grow this in real terms over a long period. Free cash flow is a financial measure of how much surplus cash a company is able to generate after funding its operating costs, working capital, capital expenditures, interest and tax. A high level of free cash flow indicates to the Investment Manager that a company has sufficient cash flow to satisfy its obligations and is able to fund investment to drive future real growth in free cash flow.

ONGOING CHARGES FIGURE

The Ongoing Charges Figure ('OCF') provides investors with a clearer picture of the total annual costs in running a Collective Investment Scheme. The OCF consists principally of the Annual Management Charge, but also includes the costs for other services paid in respect of Depositary, custody, FCA and audit fees. The Fund has a fixed periodic charge. The OCFs, as calculated in accordance with ESMA guidelines, are disclosed as 'Operating charges (p.a.)' in the Comparative Tables on pages 96 to 99.

SYNTHETIC RISK AND REWARD INDICATOR

The Synthetic Risk and Reward Indicator demonstrates in a standard format where the Fund ranks in terms of its potential risk and reward. It is based on historical performance data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The indicator uses a scale of one to seven. The higher the rank the greater the potential reward but the greater the risk of losing money. The lowest category does not mean a fund is a risk free investment. As the Fund launched on 15 July 2020, the indicator has been calculated based in part on the volatility of the Investment Association Global Sector (GBP) average over the last five years (in total return and GBP terms).

The Fund is in risk category six because its investments have experienced high volatility in the past.

IFSL EVENLODE GLOBAL EQUITY, RISK PROFILE

The stocks comprising the Index are aligned with the Fund's global focus, and on that basis the Index is considered an appropriate performance comparator for the Fund. Please note the Fund is not constrained by or managed to the Index.

The MSCI World Index is a Comparator Benchmark of the Fund.

Shareholders may also wish to compare the Fund's performance against other funds within the Investment Association's (IA) Global sector as that will give investors an indication of how the Fund is performing compared with other funds that invest in global equities. As the sector aligns with the Fund's asset allocation it is considered that this is an appropriate comparator.

The IA Global Sector is a Comparator Benchmark of the Fund.

Market Background

Markets broadly rose through the year with particular strength from December onwards as confidence in a soft landing* in the US grew. Having started the period in the tail end of 2022's sell-off (a period when investors were selling shares in large volumes leading to falling prices), we finished in the middle of another burst of exuberance, which cost the Fund in relative terms compared to the MSCI World Index due to its lower exposure to companies in the Global Industry Classification Standard (GICS) Sectors of Information Technology and Consumer Discretionary (non-essential goods and services), and the sub-sector of Capital Goods (otherwise known as industrials – includes manufacturers of machinery and equipment, commercial services and transportation).

Investment Review

Performance

The Fund (B Acc GBP share class) returned 17.6% in the year to 29 February 2024 vs its comparator benchmark the MSCI World Index which returned 19.6%. Since its launch on 15 July 2020 the Fund has returned 12% per annum on an annualised basis vs 12.4% per annum for the comparator benchmark. (Source – FE Analytics, GBP terms).

Portfolio Changes

The Fund continued to manage valuation risk and business model risk (factors that can threaten company profitability) through the year, resulting in the initial purchases of stakes in Johnson & Johnson, Beiersdorf, Clarkson, Airbnb, and Informa, and exits of its stakes in Intuit, LVMH, Synopsys, Estee Lauder, CH Robinson Worldwide, Unilever, and Aon. As with previous years, these purchases and exits were entirely in our smaller portfolio positions, with a focus on improving portfolio quality and valuation.

IFSL EVENLODE GLOBAL EQUITY, INVESTMENT REVIEW (CONTINUED)

On the purchase side, we concentrated on businesses which benefited from attractive and unusual network effects*** like Airbnb, Clarkson, and Informa, and those with robust brands, which Beiersdorf enjoys in consumer skincare, and Johnson & Johnson has in ethical drugs and medical devices (largely surgical devices). On the exit side, sales were predominantly driven by valuation, as well as concerns about the impact of certain mergers and acquisitions (Intuit and Aon), structural changes in industry (CH Robinson Worldwide), and underinvestment in consumer franchises (Estee Lauder and Unilever). We continue to monitor the exited companies.

Outlook

The broader market is markedly more optimistic year-on-year. Our sense is that expectations are framed firstly on a resilient global economy with scope for rate cuts in the year ahead, and secondly by strong optimism about the productivity benefits of machine learning innovations. Nothing has changed in our philosophy and process, and we continue to manage the Fund in order to deliver attractive organic cashflow growth in a broad variety of scenarios, with lower leverage (exposure to borrowing), cyclicity (exposure to the health of the economy), and capital intensity (amount of spending on assets necessary to support revenue) than the broader equity market.

Our objective remains to deliver capital growth over the long term, defined as five years and more. Our focus on managing valuation and business model risk aims to produce attractive returns relative to our comparator benchmark and reduce our relative volatility**, although these are not primary objectives of the Fund. We expect and accept that there will be periods of underperformance.

We continue to focus on companies which offer three critical components: differentiated competitive advantages based on hard to replicate assets; participation in structurally growing**** markets; and focus on reinvestment and long-term profitability.

'Hard to replicate assets' are always intangible (i.e. not physical) and not available for sale in the market, and broadly fall into three types: network effects***, as with Informa's B2B exhibitions franchise; switching costs, such as those enjoyed by Wolters Kluwers's workflow tools for accountants, medics, and company secretaries; and brands, as with Beiersdorf's ubiquitous 'Nivea'. Markets in structural growth**** ideally benefit from deeply rooted cultural trends, for instance increased spending on leisure travel and within it, alternative accommodation, as offered by Airbnb, or the increasing burden of age and morbid lifestyles driving Johnson & Johnson's medical franchises.

1. Accounting policies**(a) Basis of accounting**

The financial statements have been prepared under the historical cost basis, as modified by the revaluation of investments, and in accordance with Financial Reporting Standard 102 (FRS 102) and in accordance with the Statement of Recommended Practice (SORP) for Financial Statements of UK Authorised Funds issued by the Investment Association in May 2014 and amended in June 2017.

The Directors are of the opinion that it is appropriate to continue to adopt the going concern basis in the preparation of the financial statements as the assets of the Company and its sub-funds consist predominantly of readily realisable securities and accordingly the Company has adequate resources to continue in operational existence for at least the next twelve months from the approval of the financial statements.

(b) Functional currency

The functional currency used in the financial statements is Pound Sterling because it is the currency of the primary economic environment in which the Company operates.

(c) Recognition of revenue

Dividends on holdings, net of any irrecoverable tax credits, are recognised when the underlying equity is quoted ex-dividend. Bank interest is accounted for on an accruals basis.

All revenue is recognised on the condition that the flow of economic benefits is probable and the amount can be measured reliably.

(d) Treatment of stock dividends

Stock dividends are credited to the capital account when the stock is quoted ex-dividend. The cash equivalent is then transferred to the revenue account and forms part of the distributable revenue.

The allocation of special dividends is considered on a case-by-case basis in determining whether the dividend is to be treated as revenue or capital.

(e) Treatment of expenses

All expenses, except those relating to the purchase and sale of investments, are allocated to the revenue account on an accrual basis.

(f) Allocation of revenue and expense to multiple share classes

Any assets or liabilities not attributable to a particular share class are allocated by the ACD in a manner which is considered fair to shareholders in general, usually pro-rata based on the net asset values of the relevant share classes.

1. Accounting policies (continued)**(g) Taxation/deferred taxation**

Corporation tax is provided for on taxable revenue, less deductible expenses, at a rate of 20%. This is the rate that has been enacted or substantially enacted by the balance sheet date.

Deferred tax is provided for in respect of all items that have been included in these financial statements, or those of a previous period, that will be included in future periods for taxation purposes, other than those timing differences regarded as permanent. Any liability to deferred tax is provided for at the rate of tax expected to apply to the reversal of timing difference.

Income tax on interest distributions is classes as 'income tax recoverable' and is recovered on a yearly basis on submission of the Fund's annual tax return.

(h) Distribution Policy

Revenue produced by the Fund's investments is accrued annually. At the end of each year the revenue, less the expenses allocated to the revenue account, is distributed/accumulated at the discretion of the Investment Manager, as per the prospectus.

As the Fund only has accumulation shares in issue, there is no policy for unclaimed distributions.

(i) Exchange rates

Assets and liabilities in overseas currencies at the year-end are translated into Sterling at the latest available rates of exchange on the balance sheet date. Transactions in overseas currencies occurring during the year are recorded at the rate of exchange on the date of the transaction.

(j) Financial instruments

Financial assets and financial liabilities are recognised in the Fund's balance sheet when the Fund becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially recognised at transaction price (including transaction costs) and subsequently measured at amortised cost, except for the Fund's investments classified as financial assets at fair value through profit or loss, which are initially recognised at fair value (excluding transaction costs).

The investments are measured at bid prices, and quoted price for single priced funds, on the balance sheet date, with any gains or losses arising on measurement recognised in the statement of total return. If bid prices and quoted price for single priced funds are not available, the latest available prices are used. If separate offer and bid prices are quoted for shares or units, then the bid price is used. If no price or recent available price exists, the investments are valued at a price which, in the opinion of the ACD, reflects the fair value of the asset. This may involve the use of an appropriate valuation technique/methodology.

(k) Significant judgements and key sources of estimation uncertainty

There have been no significant judgements or sources of estimated uncertainty in the period.

All of the Fund's underlying financial assets are considered to be readily realisable. Where investments cannot be realised in time to meet any potential liability, the Fund may borrow up to 10% of its net asset value to ensure settlement. All of the Fund's financial liabilities are payable on demand or in less than one year.

(d) Credit risk

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. This includes counterparty and issuer risk. Cash is held with reputable credit institutions and credit risk is assessed on a regular basis.

Certain transactions in securities that the Fund enters into expose it to the risk that the counterparty will not deliver the investment for a purchase, or cash for a sale after the Fund has fulfilled its obligations. The Fund only buys and sells investments through brokers which have been approved by the ACD as an acceptable counterparty and these are reviewed on an ongoing basis.

(e) Market price risk

The value of shares/units in the underlying investments is not fixed and may go down as well as up. This may be the result of a specific factor affecting the value of an individual share/unit held within an underlying investment or be caused by general market factors (such as government policy or the health of the underlying economy) which can affect the entire portfolio.

The Investment Manager seeks to minimise these risks by holding diversified portfolios of collective investment schemes and transferable securities in line with the investment objectives. In addition, the management of the Fund complies with the Financial Conduct Authority's Collective Investment Schemes sourcebook, which includes rules prohibiting a holding greater than 20% of the assets of the Fund in any one underlying investment.

If the value of shares/units in the underlying investments were to increase or decrease by 10% the change in the net asset value of the Fund would be £42,327,610 (28 February 2023: £6,415,625). This calculation assumes all other variables remain constant.
