Objective

Portfolio securities

- The fund will invest at least 70% in inflation-linked government bonds (which are like loans to
- governments that pay a variable interest rate linked to inflation) issued anywhere in the world. The fund may also invest in inflation-linked and non-inflation-linked investment grade corporate bonds (which are like loans to companies that pay interest and are typically regarded as having a
- low default risk) and other bonds issued anywhere in the world. The fund will employ techniques to reduce (hedge) risk related to currency movements on non-sterling bonds. The fund may also invest in other funds (including those managed by abrdn), cash and assets that
- can be turned into cash quickly.
