All investments will be expected to conform to our ESG criteria.

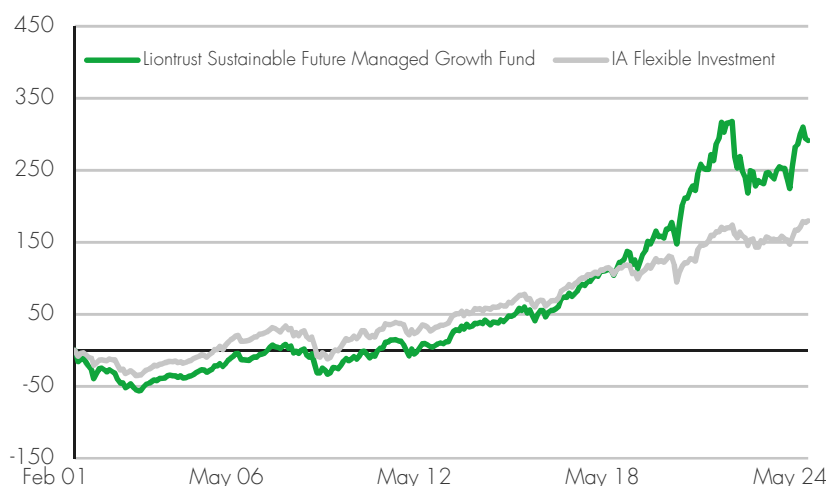
