BlackRock does not offer the facility to wrap Funds available within the BlackRock Global Funds range in an ISA and shares of this Fund range may not be held in a child trust scheme as defined by section 1(2) of the Child Trust Funds Act 2004.

If you change your mind

Dealing through Intermediaries

If you have appointed a financial intermediary to act on your behalf in regard to your investment, you may authorise us to pay initial or renewal commission in payment for their services. Initial or renewal commission is paid from our annual management charge. There is no additional cost to you. We may alternatively pay rebates (known as retrocessions) from our annual management charge in relation to distribution activities relating to the funds. The amount of the rebate is agreed between BlackRock and the intermediary but will not exceed the annual management charges for each fund as set out in the Prospectus. Further details are set out in the Prospectus which is available from BlackRock Investment Management (UK) Limited on request.

The financial intermediary should provide you with details of their legal identity, address and other contact details. They should also disclose clearly the capacity in which they will act on your behalf, and how you will be charged for the cost of their services regarding your investment in the Funds.
