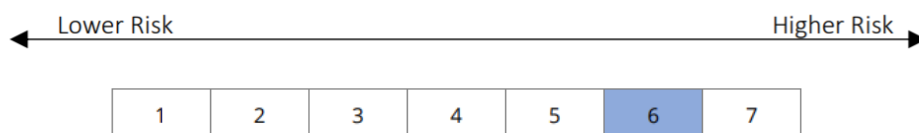
What is the product?

Type	Collateralised Exchange Traded Product (“ETP”) Securities
Objectives	GraniteShares FATANG ETP is designed to enable investors to gain 1 time exposure to a total return investment in FATANG (the “ Index”).. The product reflects the performance off the Index such that, for example, if the Index was to rise in value by 5% on a particular day, the product is designed to increase in value by 5% on that day (minus fees and adjustments) and if the Index was to fall in value by 5% on a particular day, the product is designed to decrease 5% in value by on that day (minus fees and adjustments).. The product is an exchange traded product (ETP). You may trade this product on various stock exchanges at your own discretion. You may lose the full value of your initial investment, but you will not lose more than your initial investment . The product is backed by a swap with Natixis (the “Swap Provider”). The payment obligations of the Swap Provider to GraniteShares Financial plc are protected by collateral held in a segregated account at an independent custodian , The Bank of New York Mellon SA/NV.
Intended retail investor	This product is intended for retail investors who: (i) have specific knowledge or experience of investing in similar products and in financial markets, and have the ability to understand the product and its risks and rewards; (ii) can bear the loss of capital, are not seeking to preserve capital and are not looking for capital guarantee; and (iii) have an investment horizon in line with the recommended holding period

Term of the PRIIP

This product does not have a fixed term. The term will depend on how long you choose to hold the product however, the scheduled maturity date is 01 July 2070 . GraniteShares Financial plc is entitled to terminate this product unilaterally.

What are the risks and what could I get in return?



The risk indicator assumes you hold the product for 1 day. The actual risk can vary significantly if you hold the product for a longer timeframe and you may get back less. You may not be able to sell your product easily, or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the market or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level, and poor market conditions are very likely to impact the performance.

This product does not include any protection from future market performance, so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

Be aware of currency risk. If you receive payments in a currency different to that of your home jurisdiction, the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Factors affecting the return of the product at the end of the recommended holding period

Your return on the product at the end of the recommended holding period will principally be affected by the performance of the underlying[s] over the recommended holding period and of the exchange rate between the product currency and the currency in which you bought the product.

An increase in FATANG Equal Weight Index NTR

What could affect my return negatively?

A decrease in FATANG Equal Weight Index NTR

The factors listed above provide general guidance on how changes in the Gold Spot Price may affect your return. What happens if GraniteShares Financial plc is unable to pay out?

The product is not protected by the Irish Deposit Guarantee Scheme or any other investor compensation or guarantee scheme.
