Objectives and Investment Policy

Objective: income and capital growth by investing in companies that have demonstrated sound ethical practice. The Fund aims to outperform the MSCI World Index, net of charges, over rolling five-year periods.

Policy: the Fund invests at least 80% of the value of its property in shares of companies located in developed and emerging markets anywhere in the world, and seeks to exclude companies which fail to meet the prescribed ethical standards. Investment may be direct or indirect (e.g. through collective investment schemes or derivatives), however the Manager expects that the Fund will typically hold investments directly.

The Fund operates a negative screen to avoid activities that are considered unethical such as gambling, alcohol, tobacco, animal testing and armaments. There is also a positive screen to focus the Fund's investment on companies that promote efficiency in areas such as energy, water, resources and food.

The Fund may invest in companies of any size, including smaller companies. The Fund may at times be concentrated in terms of the number of investments it holds (i.e. have less than 50 holdings). The Fund's positioning will at times be materially different from its target benchmark due to the ethical investment criteria, resulting in a different performance profile.

The Fund may use derivatives (i.e. financial contracts whose value is linked to the expected price movements of an underlying investment) with the aim of reducing the overall costs and/or risks of the Fund and/or generating additional income or growth (often referred to as 'Efficient Portfolio Management').

The Fund is managed by an investment adviser selected by the Manager for its expected ability to manage the Fund according to the investment objective and policy. The Manager continuously monitors and may periodically make changes to this appointment.

Target benchmark: the target benchmark for the Fund is the MSCI World Index. The target benchmark is representative of the companies in which the Fund typically invests. The Fund is actively managed and the Fund investments may differ from those included in the target benchmark provided they are allowed in the investment policy.

Recommendation: the Fund may not be appropriate for investors who plan to withdraw their money within five years.

Treatment of income: as units in this class are accumulation units, income from investments will be reinvested into the Fund and reflected in the value of the units.

Dealing: you can generally buy and sell units on any day on which the London Stock Exchange is open for normal business – please refer to the Prospectus for exceptions.

Risk and Reward Profile



The calculated risk and reward category, as shown above, uses a method of calculation derived from EU rules. It is based on the rate at which the returns of the Fund have moved up and down in the past (i.e. volatility) and is not a guide to the future risk and reward category of the Fund. The category shown is not a target or guarantee and may shift over time. Even the lowest category 1 does not mean a risk-free investment. The seven-category scale is nonlinear, for example, 2 is not twice as risky as 1.

Funds in category 6 have in the past shown relatively high volatility. With a fund of category 6, you have a relatively high risk of losing money but your chance for gains is also relatively high.

Investment risk - there is no guarantee that the Fund will achieve its objective. A capital loss of some or all of the amount invested may occur.

Strategy risk - the Fund invests in sectors and companies using an ethical investment strategy. This means the range of the Fund's investments may be more restrictive, and consequently the Fund may be less diversified than other investment funds.

Company shares (i.e. equities) risk - the value of company shares may rise and fall due to the performance of individual companies or because of general market and economic conditions.

Concentration risk (number of investments) - the Fund may at times hold a smaller number of investments, and therefore a fall in the value of a single investment may have a greater impact on the Fund's value than if it held a larger number of investments.

Currency risk - the Fund is denominated in British Pounds but holds assets denominated in other currencies. The value of your units may rise and fall as a result of exchange rate movements.

Derivative risk - the Fund may use derivatives for Efficient Portfolio Management (EPM). Derivatives involve a level of risk, however, for EPM they should not increase the overall riskiness of the Fund. Derivatives also involve counterparty risk where the institutions acting as counterparty to derivatives may not meet their contractual obligations.

Capital erosion risk - the Fund takes its charges from the income of the Fund in the first instance. The impact of Fund charges may be material on the value of any income you receive from your investment. There is potential for capital erosion if insufficient income is generated by the Fund to cover these charges. Capital erosion may have the effect of reducing the level of income generated.

Charges

These charges are used to pay the costs of running the Fund, including the costs of marketing and distribution. Overall, they reduce the growth of your investment.

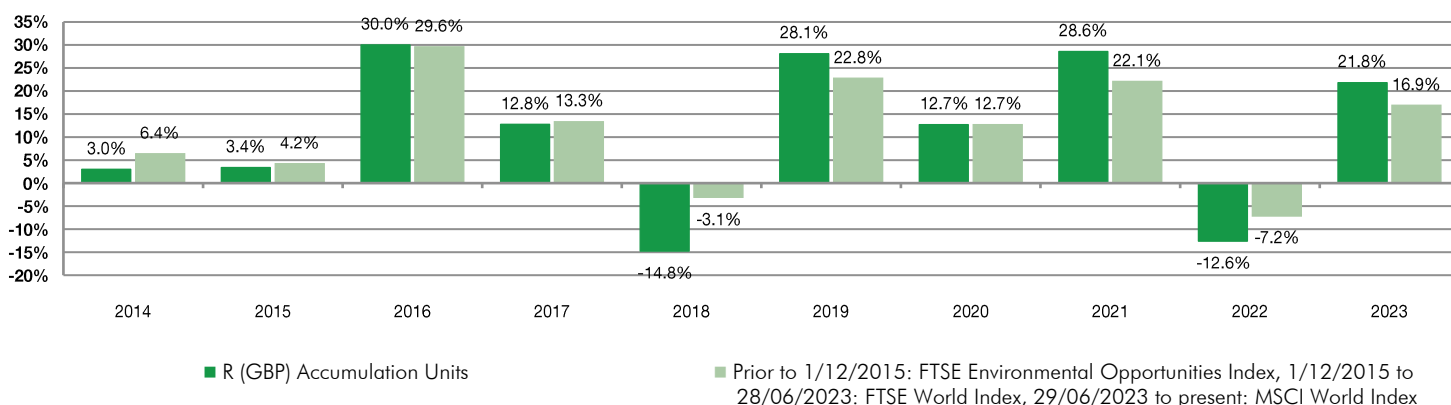
