The Fund is managed by FundRock Partners Limited.

Objective and investment policy

Objective:

- The Fund aims to achieve capital growth (the increase in value of investments) whilst operating within a volatility range (variance) of between 4% and 7% over rolling 5 year periods.
- The Fund's primary objective is to control volatility (variance) and this could therefore be at the expense of performance. There can be no guarantee that the Fund will achieve its objective of managing volatility (variance).

Policy:

- The Fund will aim to achieve its objective through investment in a variety of asset classes across multiple geographic areas and markets, including :-Between 0% and 55% in shares in companies, Real Estate Investment Trusts (REITs), Exchange Traded Funds (ETFs) and Exchange Traded Commodities (ETCs);-Between 0% and 70% in cash, near cash, bonds and money market instruments.
- The Fund will aim to have at least 80% of its exposure to these asset classes indirectly by holding units in collective investment schemes which invest in these assets.
- The Fund may hold certain financial contracts known as derivatives (which are investments whose value is linked to another investment, or the performance of a stock exchange or to some other variable factor, such as interest rates) for efficient portfolio management purposes.
- Efficient portfolio management is where the Fund is managed in a way that is designed to reduce risk or cost and/or generate extra income or growth. It is not intended that the use of derivatives in this way will change the risk profile of the Fund. On giving Shareholders 60 days' notice, the Funds will be able to also use derivatives for investment purposes.

- The Fund is actively managed.

Benchmark:

The Fund uses the Investment Association's (IA) 'Mixed Investment 20-60% Shares' Sector for performance comparison purposes only ('Performance Comparator'). The Performance Comparator was chosen because the IA Mixed Investment 20-60% Shares Sector provides an appropriate comparison of the performance of the Fund in terms of a wider group of available similar funds. The Performance Comparator is used to compare the Fund's rank or quartile as compared to the performance of other funds in the IA Mixed Investment 20-60% Shares Sector over a variety of time frames.

Other information:

- We carry out investors' requests, to buy, sell or switch, at midday on each business day (which excludes UK public holidays). If we receive a request after midday, we deal with it on the next business day.
- The Fund's base currency is Pounds Sterling.
- There can be no guarantee that the objective of the Fund will be achieved.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.
- On encashment, particularly in the short-term, you may receive less than the original amount invested.
- If you hold accumulation shares income from investments in the Fund will be rolled up into the value of your shares.

- Fixed Income / Fixed Interest - Fixed interest securities are particularly affected by trends in interest rates and inflation. If interest rates increase, capital values may fall and vice versa. Inflation will erode the real value of capital.
- Market Fluctuations - The investments of the Fund are subject to normal market fluctuations and other risk inherent in investing in securities. Appreciation in the value of investments is not guaranteed.

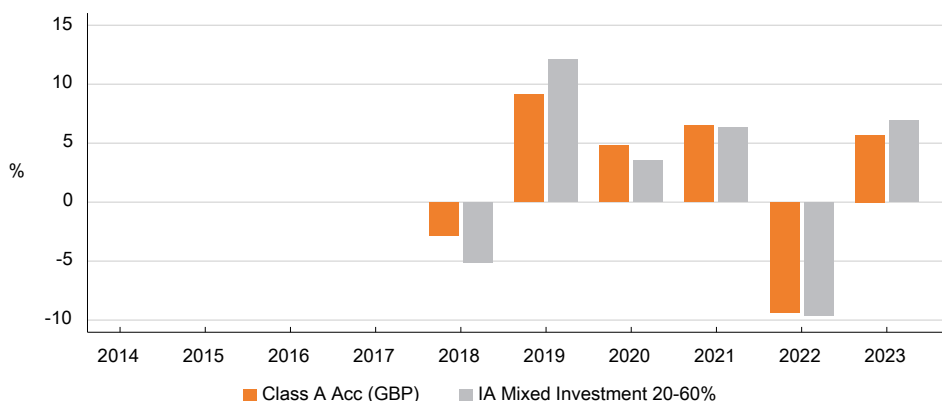
