### Objectives and investment policy

The Fund seeks to grow your capital and generate income primarily by investing primarily in Emerging countries equities or equivalent (including China A-Shares through the Shanghai Hong Kong Stock Connect up to 25%).

The Fund is actively managed and relatively concentrated (typically containing less than 50 names) with low turn-over and no restriction on the percentage invested in small and mid-capitalization.

100% of the invested companies are positive contributors to one or more environmental / social objectives.

The Fund addresses the United Nation's Sustainable Developments Goals through 6 themes, 3 environmental (healthy ecosystems, climate stability, sustainable communities) and 3 societal (basic needs, health & wellbeing, inclusive & fair economies).

The primary sustainable objective is to invest in companies which have products, services and/or processes which contribute to the solution of environmental and/or social problems as defined by the UN, including, but not limited to climate change mitigation, promotion of circular economy solutions, affordable healthcare and education, and the protection and restoration of biodiversity.

The construction of the universe is driven by positive inclusion, rather than exclusion. That is to say, through the 6 thematic lenses, the Investment Manager builds a universe through adherence to the the intensity of impact (IMAP) system and positive Environmental, Social and Governance (ESG) credentials.

The Investment Manager performs a negative screening, based on the exclusion list and ESG profile to filter the investment universe. Impact and ESG credentials are fully integrated into decision making regarding the purchase, sale and position-sizing of underlying holdings. The IMAP score in combination with ESG and financial analysis will determine the size of the positions in the portfolio.

The investment process draws from the collaboration of the Investment Manager (Union Bancaire Privée, UBP SA) with Cambridge Institute for Sustainability Leadership ("CISL"). CISL is not involved in the stock selection of this Fund. The ESG analysis covers at least 90% of the Fund's portfolio.

A performance fee in reference to the MSCI Emerging Markets Index USD (the "Benchmark") is applied to some share classes. The Benchmark is representative of the investment universe and of the risk profile of the Fund. The Investment Manager has significant discretion to deviate from the Benchmark's constituents in respect to countries, sectors, issuers and instruments, especially in view of the fact that the Benchmark is a standard reference used to frame the Fund's universe but is not aligned with the environmental and/or social characteristics promoted by the Fund.

The Fund's base currency is USD.

As an equity fund, its holdings can move in line with or return less than the broad stock market, so investors should be aware that the value of their holdings could fall and that they may not get back their initial investment.

Any income received by the Fund is reinvested (capitalisation share class).

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg.

The recommended holding period is minimum 5 years.

### Risk and reward profile

**Counterparty risk:** The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honour its contractual obligations. This may result in a financial loss for the Fund.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**Emerging countries risk:** The Fund invests in overseas countries which carry a higher risk than investing in larger established countries. Investments in Emerging countries are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in Emerging countries

rather than more developed countries may encounter difficulties when buying and selling investments. Emerging countries are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

**ESG and Sustainability risk:** It may result in a material negative impact on the value of an investment and performance of the Fund. Assessment of sustainability risks is complex and requires subjective judgments, which may be based on data which is difficult to obtain and/or incomplete, estimated, out of date or otherwise materially inaccurate. All or part of said data may come/originate from third parties.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

**Operational risk:** The Fund will be subject to operational risk, clearing settlement and custody risk when using the Shanghai Hong Kong Stock Connect and RQFII.

**Political and Social risk:** Investments in China will be sensitive to any political, social and diplomatic developments which may take place in or in relation to China. Investors should note that any change in the policies of China may adversely impact on the securities.

**Stock Connect quota limitations risk:** Investing via Stock Connect is subject to regulatory risks. The relevant rules and regulations are subject to change which may have potential retrospective effect. Stock Connect is subject to quota limitations on investment, which may restrict the Fund's ability to invest in China A-Shares through the Stock Connect on a timely basis and the Fund may not be able to effectively pursue its investment policy. Suspension risk may also occur. China Markets reserve the right to suspend trading if necessary for ensuring an orderly and fair market and managing risks prudently which would affect the Fund's ability to access the Mainland China markets.

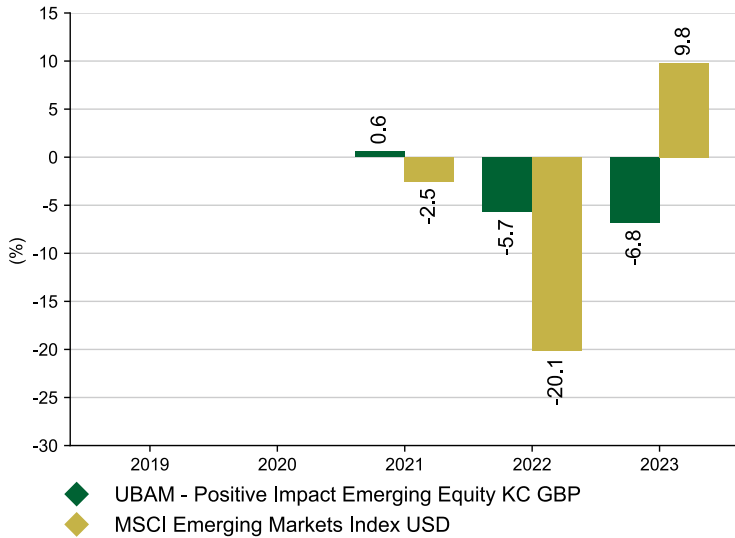
