Objectives and investment policy

The UBS Asian Smaller Companies Fund (the "Fund") aims to grow the value of your investment and outperform the MSCI All Country Asia ex Japan Small & Mid Cap Index (the "Benchmark") after charges over the medium to long term (3 to 5 years).

The Fund invests at least 80% in Asian small-cap and mid-cap equities excluding Japanese equities. Smaller companies are defined as small-cap and mid-cap equities. Small-cap companies, at the time of purchase, are generally defined as having a market capitalisation of less than USD 10 billion in terms of the company's full market capitalisation. It is anticipated that at least 50% to 70% of the Fund will usually be invested in small-cap companies. The Fund may also be invested in mid-cap companies which, at the time of purchase, are generally defined as having a market capitalisation range of between USD 10 billion and USD 40 billion in terms of the company's full market capitalisation. The Fund may have exposure to companies with market capitalisations falling outside this range.

Other information:

- The Fund may also invest in other equities, bonds, warrants, money market instruments, deposits, currencies, cash and near cash and other funds, which may be managed by UBS.
- The other funds that the Fund may invest in include funds managed by the Investment Manager or its affiliates.

- The Fund may use derivatives including forward and future contracts, swaps, options and repurchase agreements for efficient portfolio management only. It is expected that the Fund's use of derivatives will be limited.
- The Fund is actively managed in reference to the Benchmark and may hold some or all of the Benchmark constituents. The Fund generally selects equities based on an assessment of quality and long term valuations. The Investment Manager's decision-making process is driven by fundamental primary research with the aim to identify and invest in above-average quality companies that have good growth potential and trade at attractive valuations.

Investors can buy or sell shares every UK working day, except any day on which securities markets in the main countries in which the Fund invests are closed or on which 50% or more of the investments of the Fund cannot be adequately valued.

The income in respect of an accumulation share class is not distributed but is retained in the Fund and reflected in the share price.

The Fund is denominated in GBP (Sterling). As such, investors may be exposed to changes in the exchange rate between the underlying currency of the Fund's assets and GBP which may have a negative or positive impact on the returns.

Important information: This Fund may not be appropriate for investors who plan to withdraw their money within 7 years of investment.

Why is this fund in Category 6?

The fund is in category 6 because the volatility of past returns of the Index has been very high.

The risk indicator may not fully take into account the following risks.

- Equity risk: Equities (also known as shares) can lose value rapidly and typically involve higher risks than bonds.

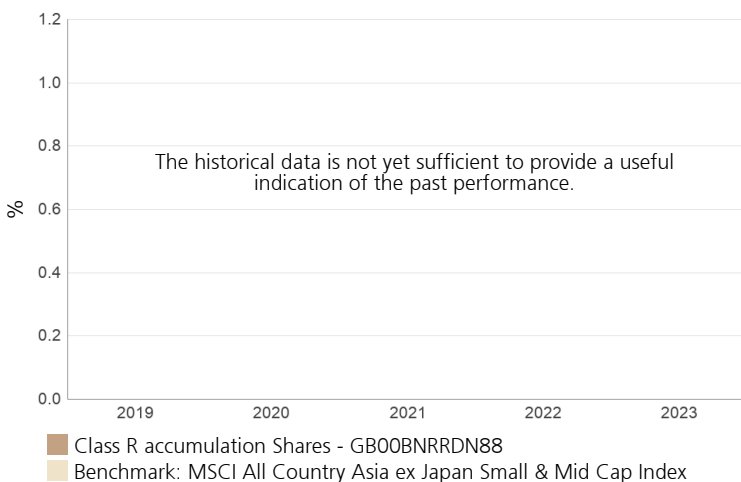
The **entry** and **exit charges** shown are maximum figures. In some cases you might pay less – you can find this out from your financial adviser.
