

Key Investor Information



This document provides you with key investor information about this fund. It is not marketing material. abrdrn Global Real Estate Share Fund, a Sterling denominated sub fund of the abrdrn OEIC V, Retail Acc Shares (ISIN: GB00B1LBR182). This fund is managed by abrdrn Fund Managers Limited.

OBJECTIVES AND INVESTMENT POLICY

Investment Objective

To generate income and some growth over the long term (5 years or more) by investing in listed closed ended real estate investment trusts ('REITs') and equities (company shares) of companies engaged in real estate activities.

Performance Target: To achieve the return of the FTSE EPRA Nareit Developed Net Return Index (Hedged to GBP) + 2% per annum over rolling three year periods (before charges). There is no certainty or promise that the Performance Target will be achieved.

The FTSE EPRA Nareit Developed Net Total Return Index (Hedged to GBP) (the "Index") is a representative index of property related companies listed on global developed stock markets.

Investment Policy

Portfolio Securities

- The fund invests at least 70% in global property related equities.
- The fund may also invest in other funds (including those managed by abrdrn), cash and assets that can be turned into cash quickly.

Management Process

- The management team use their discretion (active management) to maintain a diverse asset mix at country and company level.
- Their primary focus is on company selection using research techniques to select individual holdings. The research is focused on identifying companies the management team believe will increase in value and which align with their views regarding future economic and business conditions.
- Due to the fund's risk constraints, the fund's performance profile is not expected to deviate significantly from that of the Index.

Derivatives and Techniques

- The fund may use derivatives to reduce risk, reduce cost and/or generate additional income or growth consistent with the risk profile of the fund.
- Derivatives are linked to the value of other assets. In other words, they derive their price from one or more underlying asset.
- Where derivatives are used, this would typically be to maintain

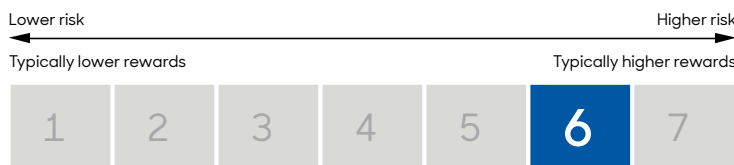
allocations while meeting cash inflows or outflows, or to manage currency risk.

Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus).

If you invest in income shares, income from investments in the fund will be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares.

Recommendation: the fund may not be appropriate for investors who plan to withdraw their money within five years. Investors should satisfy themselves that their attitude to risk aligns with the risk profile of this fund before investing.

RISK AND REWARD PROFILE



This indicator reflects the volatility of the fund's share price over the last five years which in turn reflects the volatility of the underlying assets in which the fund invests. Historical data may not be a reliable indication for the future.

The current rating is not guaranteed and may change if the volatility of the assets in which the fund invests changes. The lowest rating does not mean risk free.

The fund is rated as 6 because of the extent to which the following risk factors apply:

- **Equity Risk** - The fund invests in equity and equity related securities. These are sensitive to variations in the stock markets which can be volatile and change substantially in short periods of time.
- **Concentration Risk** - A concentrated portfolio (whether by number of holdings, geographic location or sector) may be more volatile and less liquid than a diversified one.
- **Real Estate Investment Trust (REIT) Risk** - Dividend payment policies of the REITs in which the fund invests are not representative of the dividend payment policy of the fund.
- The fund invests in emerging market equities and / or bonds. Investing in emerging markets involves a greater risk of loss than investing in more developed markets due to, among other factors, greater political, tax, economic, foreign exchange, liquidity and regulatory risks

The Ongoing Charge figure is as at 31/10/2023.

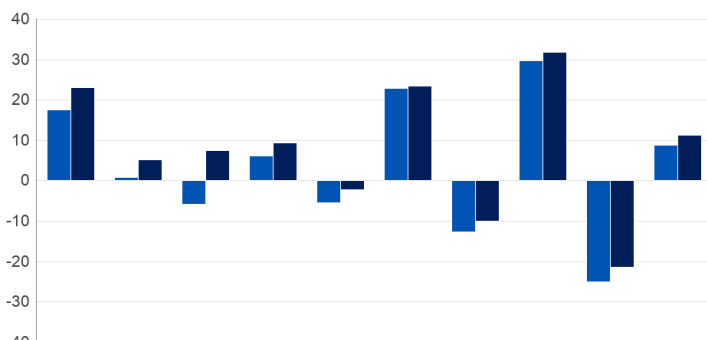
